APPOINTMENTS TO FILL VACANCIES IN THE MEMBERSHIP OF SUBSIDIARY ORGANS OF THE GENERAL ASSEMBLY

Committee on Contributions

Report of the Fifth Committee

Rapporteur: Mr. Ahmed ABOUL GHEIT (Egypt)

- 1. At its 1726th meeting, on 31 October 1975, the Fifth Committee considered a note by the Secretary-General (A/10152) concerning the vacancies which will occur in the Committee on Contributions as a result of the expiration on 31 December 1975 of the terms of office of five of its members.
- 2. The members of the Fifth Committee had been invited to submit the names of persons who might be recommended to the General Assembly for appointment to the Committee on Contributions in accordance with the provisions of rules 158 and 159 of the rules of procedure of the General Assembly. Five names were submitted for the consideration of the Committee (A/C.5/1698).
- 3. The Fifth Committee voted by secret ballot to decide on its recommendation to the General Assembly. The result of the voting was as follows:

Seven other persons received a total of 11 votes.

4. Mr. Dávila Mendoza (Mexico), Mr. Rougé (France), Mr. Ali (Pakistan), Mr. Chistyakov (Union of Soviet Socialist Republics) and Mr. Tien (China), having received the required majority, were declared recommended for appointment as members of the Committee on Contributions for a three-year term beginning on 1 January 1976.
