Summary

The present report is submitted pursuant to paragraph 19 of General Assembly resolution [71/253](#), in which the Assembly emphasized the need for the Secretary-General to inform the General Assembly at its seventy-second session of the expenses incurred and reimbursement received by the United Nations in connection with assistance provided to the International Criminal Court.

1. During the period from 1 July 2016 to 30 June 2017, Headquarters provided facilities and services to the International Criminal Court in the amount of \$771,990. The facilities and services included costs for staff who worked exclusively on matters pertaining to the Court, conference and related services, field security, library and other miscellaneous services.
2. Additional expenses in the amount of \$382,058 were incurred by the International Tribunal for the Former Yugoslavia, the United Nations Organization Stabilization Mission in the Democratic Republic of the Congo, the United Nations Office at Geneva and the United Nations Office at Nairobi for services provided for the same period.
3. The Court has regularly reimbursed the United Nations upon receipt of invoices.
4. Itemized details of facilities and services provided to the Court by Headquarters for the period are provided in annex I, and by the various offices away from Headquarters for the same period in annex II.
