### Follow-up report on individual communications\*

#### A. Introduction

1. The present report was prepared pursuant to rule 79 of the rules of procedure of the Committee on Enforced Disappearances, which states that the Special Rapporteur or working group tasked with ascertaining the measures taken by States parties to give effect to the Committee's Views shall regularly report to the Committee on follow-up activities. The Committee adopted the present report at its twelfth session.

2. The present report sets out the information received by the Special Rapporteur for follow-up on Views No. 1/2013 (*Yrusta v. Argentina*), adopted at its tenth session, and the decisions adopted in that respect in plenary in accordance with the following assessment criteria:
