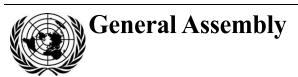

Overall orientation

- 21.1 The overall purpose of the programme is to promote the economic, social and environmentally sustainable development of Latin America and the Caribbean through international cooperation, by undertaking applied research and comparative analysis of development processes and providing the relevant normative, operational capacity development and technical cooperation services in support of regional development efforts.
- 21.2 The mandate for the programme, which falls within the purview of the Economic Commission for Latin America and the Caribbean (ECLAC), derives from Economic and Social Council resolution 106 (VI), by which the Council established the Commission for the purpose of contributing to and coordinating action towards the economic and social development of the region and reinforcing economic relationships among the countries of the region and with other regions and countries in the world. In 1996, pursuant to Commission resolution 553 (XXVI), the Commission was instructed, inter alia, to collaborate with Member States in the comprehensive analysis of development processes geared towards the design, monitoring and evaluation of public policies and the resulting provision of operational services in the fields of specialized information, advisory services, training and support for regional and international cooperation and coordination.

Note: The following abbreviations are used in tables and charts: GS, General Service; ICT, information and communications technology; LL, Local level; NPO, National Professional Officer; OL, Other level; PL, Principal level; RB, regular budget; USG, Under-Secretary-General; XB, extrabudgetary.

- 21.3 The Commission will continue to pursue key objectives shared by all the regional commissions, to support the development pillar of the United Nations, to foster economic integration at the subregional and regional levels, to promote the implementation of "Transforming our world: the 2030 Agenda for Sustainable Development" (General Assembly resolution 70/1) and the Addis Ababa Action Agenda of the Third International Conference on Financing for Development (Assembly resolution 69/313), together with the internationally agreed sustainable development goals, and to facilitate sustainable development by helping to bridge economic, social and environmental gaps between and among countries in the region and the industrialized economies.
- 21.4 To achieve those objectives, ECLAC will continue to respond to the needs of the countries in the region, serving as a regional forum and facilitator in building regional consensus, supporting public-policy formulation to meet the development challenges facing the region and promoting and conducting multilateral dialogue, sharing knowledge and networking at the interregional, regional and subregional levels. The Commission will promote intraregional and interregional cooperation through coordinated actions with other regional commissions and will collaborate with other regional organizations, particularly with United Nations entities.
- 21.5 The overall strategy of the Commission for achieving the objectives of the programme is structured around 13 interdependent and complementary subprogrammes, implemented through an integrated and multidisciplinary approach. Special efforts have been made to ensure that the gender mainstreaming strategy of the Commission is reflected throughout the present biennial programme plan.
- The integration of subprogramme 4, Financing for development, which is focused on the 21.6 mobilization of resources, with subprogramme 3, Macroeconomic policies and growth, is hereby proposed in response to the increasing demands from member States for analysis and policy proposals to tackle the new challenges for macroeconomic policymaking within the framework and targets of the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda. A key element of both agendas is a focus on domestic resource mobilization and its complementarities with external resource mobilization. The integration of the two subprogrammes will increase the capacity to design new macroeconomic policies — fiscal, monetary and financial — geared towards mobilizing domestic and external resources in line with the goals and targets outlined in the 2030 Agenda, in particular Goal 8, "Promote inclusive and sustainable economic growth, full and productive employment and decent work for all", and Goal 17, "Strengthen the means of implementation and revitalize the Global Partnership for Sustainable Development". With regard to fiscal policy, this will permit strengthening the analysis of the links between domestic fiscal efforts and fiscal coordination and cooperation at the global level, which play a central role in assessing the capacity of countries to increase their ability to mobilize domestic financing for development. It will also facilitate the introduction of new areas of work that arise from the Addis Ababa Action Agenda, namely, illicit financial flows, tax coordination and transfer pricing, among others. Synergies resulting from the integration of the two subprogrammes will allow ECLAC to better respond to demands from member countries in these new areas, as part of the fit-for-purpose efforts carried out by the Commission.
- 21.7 The main guidelines and overarching orientation for the formulation of the strategic framework for the biennium 2018-2019 were drawn from the internationally agreed development goals stemming from the major United Nations conferences and summits in the economic and social fields, in particular those set forth in the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda.
- 21.8 In the light of a sluggish global economic recovery and a fall in commodity prices, gross domestic product (GDP) growth rates in Latin America and the Caribbean have been decreasing steadily since 2010, reflecting negative growth in 2015. One of the factors that explain this result is the slowdown in domestic demand, led by a decrease in investment. Moreover, performance has been very uneven among countries and subregions, which is associated with the varying degrees of global financial integration; exposure to the real cycle of the advanced economies; the impact of

- commodity prices on the terms of trade; and the different initial conditions, institutional settings and policy measures in place in each economy.
- 21.9 In addition, the region still carries a legacy that perpetuates inequalities and exclusion mechanisms. Regional poverty rates decreased significantly between 2002 and 2012 (from 43.9 per cent to 28.1 per cent); however, in recent years they have remained relatively constant, which raises some concern that the sustained decrease has reached a plateau. These results give rise to the need to rethink public policies in this area, in a region that remains the most unequal in the world and at a time when Latin America and the Caribbean's weak social protection systems are facing tremendous redistributive challenges with limited fiscal capacity.
- 21.10 At the same time, a new global geopolitical map is taking shape, prompting a rethinking of strategic alliances and lending greater weight and importance to South-South relations. In that context, the adoption of the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda represents a change in paradigm. The 2030 Agenda seeks to be a universal agenda that integrates the economic, social and environmental dimensions as the core pillars of sustainable development. Its implementation will represent significant changes in production and consumption patterns and stake out a path towards greater equality between gender and generations, recognizing at the same time the importance of eradicating poverty until 2030.
- 21.11 To address this change in paradigm, considerable means of implementation are required. To achieve the Sustainable Development Goals, it is necessary to mobilize significant amounts of resources, technology and capacity in a difficult global environment. ECLAC has assumed ownership of this profound transformation.
- 21.12 In that regard, ECLAC advocates a single universal sustainable development agenda, with equality at its core. In order to do this, the Commission has identified as its main priorities: (a) improving macroeconomic stability and institution-building, and the region's position in the international economy; (b) increasing the region's access to international financing and domestic resource mobilization for development, as well as improving public management; (c) enhancing the region's productive potential and reducing productivity gaps to achieve convergence, with a particular emphasis on innovation and new technologies; and (d) promoting fiscal and social covenants, as well as the implementation of the 2030 Agenda for Sustainable Development, the Sustainable Development Goals and the resulting strategies and public policies, including policies and programmes on energy efficiency and climate change that take into account the outcome of the United Nations Climate Change Conference. The above-mentioned priorities were set out in the Commission's four most recent position documents, which were presented to and approved by national Governments of Latin America and the Caribbean at the four most recent biennial sessions of the Commission.
- 21.13 Given the complexity of the reform processes under way in the region and the rapidly evolving demands from member States, ECLAC will continue to provide timely and relevant analysis and policy recommendations regarding development issues. The Commission will work closely with the Governments in the region and other counterpart institutions to reinforce linkages between national experiences and regional perspectives, facilitate the comparability of data and the exchange of good practices, and provide effective technical cooperation services with regard to transboundary issues under its purview.
- 21.14 To that end, the Commission will emphasize analytical, normative, advocacy and capacity-building work to strengthen the design of sustainable development strategies and public policies and to facilitate the continuous monitoring of their practical implementation as part of the 2030 Agenda for Sustainable Development. Operational services in the areas of specialized information, technical cooperation and training will foster cooperation, networking and the sharing of good practices at the subregional, regional and interregional levels, including South-South cooperation.
- 21.15 ECLAC will continue to work on the integrated and comprehensive follow-up to the world summits from a regional perspective, in particular in articulating the region's approach to the implementation of the 2030 Agenda for Sustainable Development. For that purpose, ECLAC will

reinforce its leading role as the convener of the regional coordination mechanism to coordinate the work programme of the United Nations development pillar in the region, which reports to the Economic and Social Council and the General Assembly. At the same time, it is expected that the Forum of the Countries of Latin America and the Caribbean on Sustainable Development will be fully established and carrying out its functions with the support of the ECLAC secretariat, particularly with respect to follow-up and review at the regional level, and reporting to the high-level political forum on sustainable development at the global level, thereby linking the national, regional and global dimensions in this process. The Commission will continue its active participation to foster substantive coordination among all participating entities in the Executive Committee on Economic and Social Affairs as a key global mechanism for ensuring coherence in common thematic areas among entities of the United Nations Secretariat working in the social and economic sectors.

- 21.16 ECLAC will continue to serve as the technical secretariat for its various subsidiary bodies: the Committee of the Whole, the Committee on South-South Cooperation, the Caribbean Development and Cooperation Committee, the Regional Conference on Women in Latin America and the Caribbean, the Regional Council for Planning, the Statistical Conference of the Americas, the Regional Conference on Population and Development in Latin America and the Caribbean, the Conference on Science, Innovation and Information and Communications Technologies and the Regional Conference on Social Development in Latin America and the Caribbean.
- 21.17 Collaboration will also be continued with the Bretton Woods institutions, especially the International Monetary Fund (IMF) and the World Bank, as well as with other inter-American and Ibero-American organizations such as the Organization of American States (OAS), the Inter-American Development Bank, the Ibero-American General Secretariat and the Andean Development Corporation.
- 21.18 Furthermore, ECLAC will reinforce its close cooperation with regional mechanisms such as the Community of Latin American and Caribbean States (CELAC), the Union of South American Nations, the Caribbean Community (CARICOM), the Latin American Integration Association, the Southern Common Market (MERCOSUR), the Central American Integration System and the Bolivarian Alliance for the Peoples of Our America-Peoples' Trade Agreement. ECLAC will also strengthen its collaboration with private sector associations, non-governmental and civil society organizations, think tanks and the academic sector to promote policy dialogue and to engage them in the implementation of the sustainable development agenda.

Overview of resources

- 21.19 The overall resources proposed for the biennium 2018-2019 for this section amount to \$106,110,000 before recosting, reflecting a net decrease of \$820,400 (or 0.8 per cent) compared with the appropriation for 2016-2017. Resource changes result from two factors, namely: (a) technical adjustments relating to the removal of non-recurrent requirements and the biennial provision of new posts established in 2016-2017; and (b) other resource changes. The proposed resource level provides for the full, efficient and effective implementation of mandates.
- 21.20 The distribution of resources is reflected in tables 21.3 to 21.5.

Technical adjustments

- 21.21 Resource changes reflect the net effect of:
 - (a) An increase of \$532,000 relating to the biennial provision of resources for three new posts (1 P-3 under executive direction and management, 1 P-4 under subprogramme 9 and 1 P-3 under subprogramme 10) that were established in the biennium 2016-2017, effective 1 January 2017, pursuant to General Assembly resolution 71/272 A, in support of the implementation of the 2030 Agenda for Sustainable Development and the Addis Ababa Action Agenda;
 - (b) The removal of non-recurrent requirements totalling \$48,300 relating to activities in 2017 for the modalities for the intergovernmental negotiations of the global compact for safe, orderly and regular migration (see General Assembly resolution 71/280).

Changes within and/or across section(s)

21.22 ECLAC delivers its mandate in a large and challenging geographical region characterized by a fast-changing political, social and economic environment. To enable ECLAC to cope with current and emerging challenges, the proposed programme budget for the biennium 2018-2019 reflects the redeployment of resources among its components, without affecting its present mandates or requiring additional resources. The proposed redeployments have zero net effect on resources, as presented under each component.

Other changes

- 21.23 Resource changes reflect a reduction of \$1,304,100, made possible from efficiencies that ECLAC plans to bring about in the biennium 2018-2019. The proposed reduction is a result of, inter alia, the efforts of ECLAC to apply the anticipated Umoja efficiencies presented in the eighth progress report of the Secretary-General on the enterprise resource planning project (A/71/390) to individual day-to-day operations. The Umoja efficiencies set out in the eighth progress report were based on the Organization's experience with the system, anticipated future changes, including future roll-outs, a global review of end-to-end processes, the retirement of legacy systems and improvements to business process and planning capabilities. Efficiencies were expressed, inter alia, as the dollar value of a full-time equivalent, where applicable. Further information on the approach is provided in the foreword and introduction of the proposed programme budget for the biennium 2018-2019.
- 21.24 For ECLAC, the post and non-post reduction of \$1,304,100 reflects a \$5,000 reduction under policymaking organs, a \$358,600 reduction under executive direction and management, a \$128,400 reduction under programme of work and a \$812,100 reduction under programme support.

Extrabudgetary resources

- 21.25 ECLAC receives both cash and in-kind contributions, which complement regular budget resources and continue to be vital in the delivery of its mandates. Under extrabudgetary resources, projected cash contributions of \$25,351,100, reflecting a decrease of \$1,961,400 compared with revised estimates for the biennium 2016-2017, will be used to undertake analytical studies and technical cooperation activities, including advisory services, assistance and support to the countries of the region, and will complement field projects and training courses for policymakers to strengthen their institutional capacity to address a broad range of development, economic, social and environmental issues with a regional perspective. Over the past bienniums, extrabudgetary resources in ECLAC have shown a trend of decrease owing, on the one hand, to the global financial crisis, and on the other, to the global trend of refocusing the main flows of development cooperation initiatives to other geographical areas, since most Latin American and Caribbean countries are currently considered middle-income economies. In that regard, efforts are being undertaken to stabilize extrabudgetary resources, including by expanding the portfolio of projects and by reaching out to non-traditional donors, in order to maintain the Commission's capacity to respond to the needs of member States on technical cooperation.
- 21.26 ECLAC receives in-kind contributions under "donated right to use" arrangements, which complement regular budget resources and continue to be vital in the delivery of its mandates.
- 21.27 Anticipated in-kind contributions would provide for rent-free premises for the ECLAC national office in Brasilia, with an estimated value of \$223,800 for the biennium, and donated right-to-use land for ECLAC premises in Santiago, with an estimated value of \$1,253,700 for the biennium.

Other information

- 21.28 Pursuant to General Assembly resolution 58/269, the Secretary-General has been requested to identify resources for the conduct of monitoring and evaluation functions. In this connection, an amount of \$891,400 has been identified for monitoring, self-evaluation and evaluation activities under section 21. The provision, which represents a total of 58.3 work-months of staff in the Professional category and 29 work-months of Local level staff, comprises \$778,400 from regular budget post-related resources (reflected under each subprogramme) and \$10,000 from extrabudgetary post-related resources; and \$13,800 in non-post resources from regular budget resources and \$89,200 in non-post resources from extrabudgetary resources. Requirements under business continuity in the amount of \$148,100 for the biennium 2018-2019 are based on the provision of support elements for critical staff who would be responsible for maintaining critical functions in ECLAC in the event of a crisis or business interruption and would, therefore, require remote access to data and computer applications.
- 21.29 ECLAC will continue to serve as the technical secretariat of its subsidiary bodies, namely, the Committee of the Whole, the Committee of High-Level Government Experts, the Caribbean Development and Cooperation Committee, the Central American Economic Cooperation Committee, the Statistical Conference of the Americas and the meetings of its Presiding Officers, the Regional Council for Planning of the Latin American and Caribbean Institute for Economic and Social Planning (ILPES) and the meetings of its Presiding Officers, the Regional Conference on Population and Development in Latin America and the Caribbean, the Conference on Science, Innovation and Information and Communications Technologies, and the Regional Conference on Social Development in Latin America and the Caribbean. Collaboration will also be continued with IMF, the World Bank, the other Bretton Woods institutions and inter-American and Ibero-American institutions such as OAS, the Ibero-American General Secretariat and the Inter-American Development Bank.
- 21.30 In addition, ECLAC will collaborate closely with new emerging regional mechanisms, such as CELAC, the Union of South American Nations and the Bolivarian Alliance for the Peoples of Our America People's Trade Agreement, and reinforce cooperation with CARICOM, the Latin

American Integration Association, MERCOSUR and the Central American Integration System. ECLAC will also strengthen its collaboration with private sector associations, non-governmental organizations, think tanks and the academic sector to promote policy dialogue and to engage them in the implementation of the 2030 Agenda for Sustainable Development and the Sustainable Development Goals.

21.31 Following a review of the publications pertaining to each subprogramme, it is anticipated that recurrent and non-recurrent publications will be issued as summarized in table 21.6 and as distributed in the output information for each subprogramme.

A. Policymaking organs

Resource requirements (before recosting): \$1,576,100

21.32 The Commission comprises 45 members and 13 associate members and holds biennial sessions for five days during even-numbered years to review the work of the ECLAC secretariat and approve its biennial programme of work. The biennial session has an ad hoc committee on South-South cooperation. The thirty-seventh session of ECLAC is scheduled to be held in Havana during the first half of 2018.

Committee of the Whole

21.33 The Committee of the Whole was established in 1952. It normally meets at United Nations Headquarters with permanent representatives of ECLAC member States during the years in which the Commission does not hold a biennial session. The thirty-third and thirty-fourth plenary sessions of the Committee of the Whole are scheduled to be held in New York for three days in 2018 and 2019 to discuss issues of concern to the Commission.

Committee of High-Level Government Experts

21.34 The Committee of High-Level Government Experts was established on 7 May 1971. It is a subsidiary organ of the Commission and acts as a forum devoted to the analysis of various aspects of the implementation and appraisal of development strategies in Latin America and the Caribbean. It meets, if and when required, annually. The Committee is scheduled to meet in New York in 2018 and 2019.

Caribbean Development and Cooperation Committee

21.35 The Caribbean Development and Cooperation Committee was established in 1975. It coordinates economic and social development cooperation and addresses other development concerns of the Caribbean members of ECLAC. It also serves as an advisory and consultative body to the Executive Secretary of ECLAC on issues concerning the Caribbean. The Committee is scheduled to meet in Castries in 2018 and Kingston in 2019.

Central American Economic Cooperation Committee

21.36 The Central American Economic Cooperation Committee was established in 1952. It provides overall coordination and direction to the secretariat in relation to activities to promote the integration of national economies in Central America. It also serves as an advisory and consultative body to the Executive Secretary of ECLAC on issues related to the Central American region and as a subsidiary organ of the Commission. The Committee is scheduled to meet in Santiago in 2018 and 2019.

Regional Conference on Women in Latin America and the Caribbean and Presiding Officers of the Regional Conference

- 21.37 The Regional Conference on Women in Latin America and the Caribbean was established as a permanent subsidiary body of ECLAC at the eleventh extraordinary session of the Committee of the Whole, on 21 November 1977. The purposes of the Regional Conference are to identify women's needs at the regional and subregional levels, submit recommendations, undertake periodic assessments of the activities carried out in fulfilment of regional and international plans and agreements on the subject and serve as a forum for debates on relevant issues. Its sessions are held every three years and it is scheduled to meet in Santiago in 2019.
- 21.38 The Presiding Officers provide overall direction on the work of the secretariat on issues related to the integration of women into development in the region in intersessional intervals of the conference, in accordance with paragraph 88.2 of the Regional Plan of Action for the Integration of Women into the Economic and Social Development of Latin America and the Caribbean. The Presiding Officers are scheduled to meet on three occasions during the biennium 2018-2019: in Port of Spain and in Santiago in 2018, and in San José in 2019.

Regional Council for Planning of the Latin American and Caribbean Institute for Economic and Social Planning and Presiding Officers of the Regional Council

- 21.39 The Regional Council for Planning of ILPES, comprising 40 member Governments, was established in 1974. It is the principal intergovernmental body of ILPES and meets every four years. It is scheduled to meet in Kingston in 2019.
- 21.40 The Presiding Officers of the Regional Council for Planning, comprising 11 member Governments, examine the programme of work for ILPES and evaluate past activities. The Presiding Officers are scheduled to meet in Santiago in 2018.

Statistical Conference of the Americas and the Executive Committee of the Statistical Conference

- 21.41 The Statistical Conference of the Americas was established as a subsidiary organ of the Commission, pursuant to Commission resolution 580 (XXVIII) and Economic and Social Council resolution 2000/7.
- 21.42 The Conference meets on a biennial basis with the objectives of promoting the development and improvement of national statistics and their international comparability, strengthening cooperation among national statistical offices and international and regional agencies, and preparing a biennial programme of regional and international cooperation to meet the demands of the countries of the region in the field of statistics. The Conference is scheduled to meet in Buenos Aires in 2019.
- 21.43 The Executive Committee of the Statistical Conference of the Americas supports the elaboration of technical reports on the advances and the results achieved under the programme of work defined by the Conference. The Executive Committee is scheduled to meet twice in 2018, in Bogota and Santiago, and in Santiago in 2019.

Regional Conference on Population and Development

21.44 By ECLAC resolution 670 (XXXIV), the Ad Hoc Committee on Population and Development of ECLAC was replaced by the Regional Conference on Population and Development in Latin

America and the Caribbean. The Conference has the objective of reviewing and following up on all issues related to population and development, including demographic trends to be used in the formulation process of evidence-based public policies, and other issues related to ageing, international migration, indigenous peoples and people of African descent. The Regional Conference, held biennially, is scheduled to meet in Buenos Aires in 2019.

Conference on Science, Innovation and Information and Communications Technologies of the Economic Commission for Latin America and the Caribbean

- 21.45 The Conference on Science, Innovation and Information and Communications Technologies of ECLAC was approved as a subsidiary organ of the Commission at the thirty-fourth session of ECLAC (see resolution 672 (XXXIV)).
- 21.46 The Conference holds regular meetings annually with the following objectives: (a) to promote the development and improvement of national policies on science, technology and innovation and those related to the progress of the information and knowledge society, bearing in mind the recommendations made by the specialized agencies and other relevant organizations; (b) to further international, regional and bilateral cooperation among ECLAC, national institutions and international and regional agencies to facilitate technology and knowledge transfer and joint activities in the field of science, technology and innovation; and (c) to prepare a biennial programme of regional and international cooperation activities designed to meet the needs of the countries of the region on relevant matters, subject to the availability of resources.
- 21.47 The Conference is scheduled to meet in Bogota in 2018 and in Santiago in 2019.

Regional Conference on Social Development in Latin America and the Caribbean and Presiding Officers of the Regional Conference

- 21.48 The Regional Conference on Social Development in Latin America and the Caribbean was approved as a subsidiary organ of the Commission at the thirty-fifth session of ECLAC (Lima, 5-9 May 2014) (see ECLAC resolution 682 (XXXV)).
- 21.49 The Conference holds regular meetings every two years, with the following objectives:

 (a) promote the development of national policies on social development, bearing in mind national requirements and recommendations made by specialized agencies and other relevant organizations;

 (b) further international, regional and bilateral cooperation among ECLAC, national offices and institutions and international and regional agencies to facilitate technology and knowledge transfer and joint activities in the field of social development; (c) examine multidimensional poverty and make progress on poverty measurement, inequality and structural gaps, in conjunction with the relevant subsidiary bodies that conduct studies in the field, in particular the Statistical Conference of the Americas; (d) exchange experiences in relation to social matters and support and provide technical inputs for summits of the Heads of State and Government of CELAC and other regional forums; and (e) contribute to the discussions and proposals considered by the Commission on Sustainable Development from the perspective of countries of the Latin American and Caribbean region.
- 21.50 The Presiding Officers meet at least once during the interval between regular sessions of the Conference. The Presiding Officers of the Conference are scheduled to meet in Bogota in 2018; the Regional Conference is scheduled to meet in Guatemala City in 2019.
- 21.51 The distribution of resources for the policymaking organs is reflected in table 21.7.

The amount of \$1,576,100, reflecting a decrease of \$5,000 compared with the appropriation for the biennium 2016-2017, provides for the servicing of the meetings of ECLAC intergovernmental bodies. The decrease of \$5,000 reflects reductions resulting from efficiencies that the Office plans to bring about in the biennium 2018-2019.

B. Executive direction and management

Resource requirements (before recosting): \$7,360,400

- 21.53 The Executive Secretary (USG), assisted by the Deputy Executive Secretary (D-2), provides overall guidance, supervision and management to ECLAC to implement legislative mandates and the approved programme of work. It is responsible for the coordination of the preparation of an institutional document on the main substantive topics to be discussed at the biennial session of the Commission, as well as for the publication *CEPAL Review*.
- 21.54 In addition, the Office of the Executive Secretary provides leadership and policy orientation and establishes the criteria to coordinate follow-up in the region on the implementation of the 2030 Agenda for Sustainable Development, including the Sustainable Development Goals, and the Addis Ababa Action Agenda, and the mainstreaming of cross-cutting issues, such as gender and sustainability perspectives, throughout ECLAC substantive programmes. It is also responsible for coordinating its programme of work with other funds, programmes and specialized agencies of the United Nations system in the region. The Office includes the Office of the secretariat of the Commission, which is responsible for maintaining political relations with the Governments and authorities of ECLAC member States and for performing diplomatic and protocol functions and is entrusted with servicing intergovernmental meetings.
- 21.55 The Programme Planning and Operations Division, headed by the Deputy Executive Secretary for Management (D-2), will continue to provide overall coordination, guidance and advice to the ECLAC subprogramme managers with respect to the formulation of the proposed biennial programme plan and priorities and its revisions; the preparation of the draft programme of work and the biennial report on the activities of the Commission for consideration and adoption at the biennial session of the Commission; and the preparation of the biennial proposed programme budget and subsequent budget and programme performance reports.
- 21.56 The Division will continue to: (a) monitor and evaluate the implementation of the programme of work, including the mandatory self-assessment exercise and discretionary internal evaluations; (b) enhance the evaluation work by undertaking selected project, subprogramme and thematic evaluations according to the risks and needs of the organization; (c) carry out budget planning with a results-based orientation and further expand the results-based management practices of ECLAC; and (d) coordinate and provide guidance and supervision for the ECLAC technical cooperation programme and the relevant fundraising activities, carried out in the Project Management Unit.
- 21.57 The Public Information Unit at ECLAC headquarters in Santiago is a component of executive direction and management. The Unit is headed by a staff member in a P-5 post, who is accountable to the Executive Secretary and works in close coordination with the Department of Public Information.

- 21.61 The amount of \$7,360,400, reflecting a net decrease of \$70,700 compared with the appropriation for 2016-2017, would provide for the financing of 32 posts (1 Under-Secretary-General, 2 D-2, 4 P-5, 1 P-4, 3 P-3, 1 P-2, 19 Local level and 1 National Professional Officer) (\$6,378,700) and for non-post requirements, including other staff costs, consultants, travel of staff, contractual services, general operating expenses, supplies and materials, and furniture and equipment (\$981,700), to support the implementation of mandates under the programme.
- 21.62 The net decrease of \$70,700 reflects the proposed decrease of \$358,600 under non-post requirements resulting from efficiencies that ECLAC plans to bring about in 2018-2019, offset in part by the proposed increase of \$287,900 under posts owing to:
 - (a) The inward redeployment of one post of Procurement Assistant (Local level) from the Procurement Unit in programme support to the Programme Planning and Operations Division in executive direction and management to support certifying and monitoring functions related to changes in procurement practices, policies and thresholds, following implementation in Umoja;
 - (b) The biennial provision of resources for one temporary P-3 post established in the biennium 2016-2017, effective 1 January 2017, pursuant to General Assembly resolution 71/272 A, in

21.63 During the biennium 2018-2019, extrabudgetary resources are expected to amount to \$1,505,100 to support the activities carried out within this component.

- 21.95 The amount of \$3,975,300, reflecting a net decrease of \$191,100 compared with the appropriation for 2016-2017, would provide for the financing of 17 posts (1 D-1, 1 P-5, 4 P-4, 4 P-3, 2 P-2 and 5 Local level) (\$3,697,100) and for non-post requirements, including other staff costs, consultants, expert groups, travel of staff and contractual services (\$278,200), to support the implementation of mandates under the programme.
- 21.96 The net decrease of \$191,100 reflects:
 - (a) The proposed outward redeployment of one post of Social Affairs Officer (P-4) to subprogramme 13, Support for regional and subregional integration and cooperation processes and organizations, to support the strengthening of the activities of the Commission towards enhancing regional integration mechanisms and foster regional cooperation;

- 21.162 The amount of \$1,113,800, reflecting a net increase of \$632,500 compared with the appropriation for 2016-2017, would provide for the financing of four posts (1 D-1, 1 P-4, 1 P-3 and 1 Local level) (\$985,700) and for non-post requirements, including other staff costs, consultants, expert groups and travel of staff (\$128,100), to support the implementation of mandates under the programme.
- 21.163 The net increase of \$632,500 reflects the proposed inward redeployment of one post of Chief of Service (D-1) from subprogramme 3, Macroeconomic policies and growth, and one post of Social Affairs Officer (P-4) from subprogramme 4, Social development and equality, to support the strengthening of the activities of the Commission towards enhancing regional integration mechanisms and foster regional cooperation, offset in part by non-post reductions resulting from efficiencies that the Commission plans to bring about in 2018-2019.

D. Programme support

Resource requirements (before recosting): \$36,821,100

- 21.164 The activities carried out under programme support comprise conference and documentation services, library services, management of technical cooperation activities and administration and common services.
- 21.165 Programme support activities include:
 - (a) Conference and documentation services, whose functions relate to the provision of substantive services for the meetings of the intergovernmental organs of ECLAC, the provision of conference and documentation services to ECLAC and the publications programme and the distribution of ECLAC and United Nations Headquarters publications;
 - (b) Library services providing information services to ECLAC staff members and external users, the publication of bulletins and bibliographies on a periodic basis and the provision of services to remote users through the Internet. Furthermore, the ECLAC Library acts as the United Nations repository library in Chile, concentrating all the official documentation produced by the Organization;
 - (c) Management of technical cooperation activities formulated to complement the regular budget resource allocation. This component is geared to strengthening and expanding the economic, social and environmental research agenda and the application of research findings to the provision of advisory services and training activities for the benefit of ECLAC member States:
 - (d) Administration and common services providing the overall management and coordination of administrative services, policy formulation and the establishment of managerial and administrative guidelines at ECLAC, human resources management, financial management,

general support services, language training, electronic information activities, the International Public Sector Accounting Standards and Umoja.

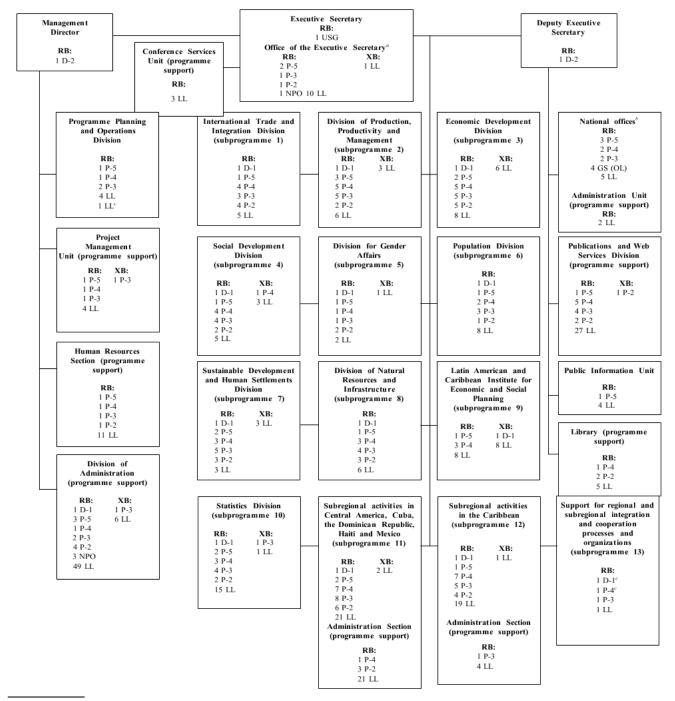

- 21.167 The amount of \$36,821,100, reflecting a decrease of \$1,218,800 compared with the appropriation for 2016-2017, would provide for the financing of 166 posts (1 D-1, 6 P-5, 10 P-4, 9 P-3, 12 P-2, 2 National Professional Officer and 126 Local level) (\$24,290,600) and for non-post requirements, including other staff costs, travel of staff, contractual services, general operating expenses, hospitality, supplies and materials, and furniture and equipment (\$12,530,500), to support the implementation of mandates under the programme.
- 21.168 The decrease of \$1,218,800 reflects:
 - (a) Decreased requirements under posts owing to:
 - (i) The proposed outward redeployment of one post of Procurement Assistant (Local level) to executive direction and management to support certifying and monitoring functions related to changes in procurement practices, policies and thresholds following the implementation of Umoja;
 - (ii) The proposed abolishment of one post of Integrated Management Information System Coordinator (P-4), one post of Associate Translator, English (P-2), two posts of Property and Inventory Control Assistant (Local level) and one post of Travel Assistant (Local level), reflecting efficiencies that the Commission plans to bring about in 2018-2019;
 - (b) Decreased requirements under non-posts, reflecting the outward redeployment of resources to the programmatic area to cover the cost of external printing and specialized services for the graphic design and layout of the flagship publications, and other non-post reductions resulting from efficiencies that the Commission plans to bring about in 2018-2019.
- During the biennium 2018-2019, expected extrabudgetary resources amounting to \$1,274,900 will be utilized to cover programme support costs related to various technical cooperation projects.

Office of Internal Oversight Services

Evaluation of the Economic Commission for Latin America and the Caribbean (E/AC.51/2015/6)

ECLAC should, within its mandates, assess its strategies and structure in order to achieve greater convergence between its thematic areas of work and its three core functions and to ensure the effective use of its available resources (para. 74, recommendation 1).

The proposed programmatic structure of ECLAC for the biennium 2018-2019 already incorporates an analysis of convergence and efforts to strengthen the synergies between subprogrammes in order to respond in a more efficient manner to member States' mandates, in particular those deriving from the new requirements of the implementation of the 2030 Agenda for Sustainable Development and the Sustainable Development Goals.

One example of the efforts is the proposal included in the ECLAC strategic framework and programme of work for the biennium 2018-2019 to merge subprogramme 3, Macroeconomic policies and growth, with former subprogramme 4, Financing for development, to respond more effectively and efficiently to the new demands from countries in the Latin American and Caribbean region in the light of the requirements of the 2030 Agenda for Sustainable Development. Merging the two subprogrammes will facilitate the adoption of an integrated approach to the thematic areas of domestic resource mobilization and external resources to finance development. It will also facilitate the incorporation of new topics into the analysis and discussion, which will contribute to the design and implementation of macroeconomic policies in connection with fiscal, monetary and financial matters, as well as labour market policies, to support economic growth and achieve sustainable development in the countries of the region.

ECLAC has established its regional forum for sustainable development. As part of the related work, ECLAC is revising and updating its engagement strategy with the countries of the region.

ECLAC should develop and implement an engagement strategy vis-à-vis national policymakers in technical ministries throughout the region. Such a strategy should include: (a) regular dissemination of information about the work of ECLAC; and (b) annual consultations with Governments (both central agencies and technical ministries), jointly undertaken by headquarters divisions and subregional headquarters, to brief them on relevant planned, ongoing and completed work and to discuss the country's needs and priorities (para. 74, recommendation 2).

Action taken to implement the recommendation

ECLAC should put in place a formal mechanism to ensure that the decisions of the Caribbean Development and Cooperation Committee are incorporated into the work programmes of all the relevant headquarters substantive divisions (para. 74, recommendation 3).

ECLAC should improve the effectiveness of its knowledge dissemination by developing an outreach strategy that guides the issuance of every knowledge product (publication) that it delivers. Such a strategy should include an action plan, a budget and measures for the monitoring of the output's utility (para. 74, recommendation 4).

ECLAC is working on the preparation of a guidance note to facilitate the implementation of the anticipated actions described in its response to this recommendation, detailed below.

ECLAC will continue with the ongoing practice by which the Chair of the Caribbean Development and Cooperation Committee reports on the implementation of the decisions adopted by the Committee to the Plenary of the Commission.

In the context of the strategic planning meetings held with substantive divisions at ECLAC headquarters, ECLAC will ensure that decisions of the Caribbean Development and Cooperation Committee adopted by the Plenary of the Commission are, when feasible, informed by and incorporated in the programme of work of the divisions.

Progress made will also be monitored in the context of these meetings and through the formal monitoring and reporting process in place.

ECLAC will formally report on the implementation of progress in this regard through a dedicated section of the report on the activities of the Commission.

During the past two years, ECLAC has executed an ambitious project of profound change and renewal of its website, both in terms of architecture and content, with the aim of positioning the web as a strategic tool for access to and dissemination of information. The new ECLAC website (www.cepal.org) and the digital repository (http://repositorio.cepal.org) are the main vehicles for the dissemination of all official publications and other content, such as statistics, press releases, speeches, news, statements, infographics, events and seminars, training, and live streaming of public events.

Major improvements relate to the establishment of governance policies for special sites, updating observatories with data visualization technologies and centralizing the management of user subscriptions using a customer relationship management system, which allows for the effective dissemination of news and outstanding content of ECLAC to more than 50,000 subscribers. The impact of every campaign made through the system is being measured systematically.

Action taken to implement the recommendation

With regard to inclusiveness, it is to be noted that the new website incorporates Web Content Accessibility Guidelines (WCAG 2.0), enabling access for people with disabilities and making web content more usable in general.

Mobile applications were developed and have been integrated with the main website and special conference sites, reaching more than 6,000 users.

With the introduction of the digital repository, all official documents published by ECLAC are now stored in one central location. This has significantly facilitated version control, searchability and access to the entire compilation of documents.

ECLAC has established governance procedures to publish documents in the digital repository. Documents are accessed directly from the website, avoiding duplication of content and penalizations on the main search engines, and ECLAC is participating in networks for the dissemination of information, particularly in the academic sector.

Additionally, ECLAC has been implementing data segmentation throughout the Commission by substantive area, along with search engine optimization and improvements in response times.

Since 2015, ECLAC has started to use electronic publishing platforms to disseminate new publications.

For the launching of flagship publications and other important events, ECLAC is transmitting live through web streaming or web conference technologies. Campaigns on social networks are started alongside each event. Traffic has increased steadily since implementation and now press media not able to attend physically can watch live transmissions or recorded events.

ECLAC is currently in the process of creating a formal knowledge management strategy; a first draft has been finalized and distributed to the members of the knowledge management group of ECLAC for their revision.

As stated in the recommendations implementation plan, ECLAC has already engaged in a process of reinforcing the evaluation function by dedicating one P-4 post and, partially, one post of Research Assistant (Local level) to the function. Since 2013, and in the case of full-fledged evaluations, action plans for implementing evaluation recommendations and the monitoring of its implementation have become ongoing practice, as stated in the evaluation policy and strategy of ECLAC.

ECLAC should strengthen its evaluation function by establishing a separate evaluation unit with the necessary competencies and resources; identifying and undertaking periodic, risk-based evaluations across the subprogrammes; and following up on the implementation of the evaluation recommendations to promote accountability (para. 74, recommendation 6).

Action taken to implement the recommendation

As proposed in the management response to the Office of Internal Oversight Services, ECLAC has held consultations with the Programme Planning and Budget Division to request its approval to present, within the framework of the proposed programme budget for the biennium 2018-2019, a proposal for the creation of a dedicated and independent evaluation unit, which would require additional resources to ensure adequate human and financial resources for the correct operation of the unit. In a memo dated 18 November 2016, the Division has not granted permission to include such proposal in the proposed programme budget for the biennium 2018-2019.

Detailed results on an audit of financial and human resources management in the Economic Commission for Latin America and the Caribbean

ECLAC should initiate the updating of the Secretary-General's bulletin on the organization of its secretariat to reflect changes to its mandate and administrative reporting lines (recommendation 1).

The Department of Management should take action to strengthen the method of delegating authority under the Financial Regulations and Rules of the United Nations to ensure officials to whom authority is delegated can be held accountable (recommendation 2).

ECLAC should take action to ensure that officials accepting voluntary contributions and overseeing programme support costs have appropriate delegation of financial authority (recommendation 3).

ECLAC should: (a) implement a procedure to revoke the authority of staff no longer performing certifying and approving functions to ensure adequate segregation of duties; and (b) conduct a review of the panel of certifying or approving officers to ensure that it is valid and current (recommendation 4). ECLAC has revised the Secretary-General's bulletin on the organization of its secretariat to reflect changes to its mandate and administrative reporting lines. Final approval is pending from the Executive Secretary.

ECLAC was informed during consultations that as delegations of authority are now dependent on functions and posts, the staff members' signature of their contract with the Organization legally binds them to their delegation/function/post, which makes them accountable for their actions. A note to the Controller's office to follow up on the recommendation will be issued.

ECLAC, upon approval by the Executive Secretary of the revised Secretary-General's bulletin on the organization of its secretariat, which reflects changes to its mandates and administrative reporting lines, shall submit to the Controller's office a request to issue revised delegations of authority for officials accepting voluntary contributions and overseeing programme support costs.

In a memorandum issued to the Human Resources Section on 28 October 2016, the Administration instructed the Section to incorporate in form P.35, "Certificado de descargo", a new field. All staff members who retire or leave ECLAC are required to state in the new form if they performed certifying/approving/bank signatory and/or credit card holder functions. The Administration is now able to revoke delegations upon having received the P.35 form.

All lists of bank signatory panels, credit card holders, petty cash officers and certifying and approving officers have been revised and updated.

Action taken to implement the recommendation

ECLAC should take action to make advance plans for its meetings, workshops and training courses so that the lists of participants can be finalized in time to comply with the travel policy of purchasing tickets at least 16 days in advance of actual travel (recommendation 5).

The Administration issued a circular dated 31 October 2016 reminding staff of the administrative circular issued on 27 August 2013 and administrative instruction ST/AI/2013/3, on official travel, stating that requests for purchasing tickets upon implementation of Umoja are to be performed 21 days in advance and providing detailed guidance of the processes, as well as of the roles and accountability of each of the parties involved.

ECLAC should perform self-evaluations on all key performance indicators under the human resources management objective and put in place remedial measures to achieve or maintain the targets (recommendation 6).

The Human Resources Section has been requested to issue a report to the management committee every two months in order to inform it of the status of key performance indicators and enable the committee to take the appropriate remedial actions to maintain or achieve the targets accordingly.
