> QUESTION CONSIDERED BY THE SECOND EMERGENCY SPECIAL SESSION OF THE GENERAL ASSEMBLY FROM 4 TO 10 NOVEMBER 1956

Draft resolution: Argentine, Australia, Belgium, Chile, Colombia, Denmark, Dominican Republic, El Salvador, Ireland, Italy, Netherlands, Norway, Pakistan, Peru, Philippines, Spain, Sweden, Thailand, Turkey, United States of America

The General Assembly,

Deeply concerned over the tregic events in Hungary,

Recalling those provisions of the resolutions of the General Assembly of 4, 9 and 21 November and of 4 December 1956, $\frac{1}{2}$ celling upon the Government of the Union of Soviet Socialist Republics to desist from its intervention in the internal affeirs of Hungary, to withdraw its forces from Hungary, and to cease its repression of the Rungarian people.

Recalling also those provisions of the resolutions of the General Assembly of 4 and 21 November 1956 calling for permission for United Nations observers to enter the territory of Hungary, to travel freely therein, and to report their findings to the Secretary-General,

Eaving received the report of the Secretary-General (A/3403) of 30 November 1956 stating that "no information is available to the Secretary-General concerning steps taken in order to establish compliance with the decisions of the General Assembly which refer to a withdrawal of troops or related political matters", and the note of the Secretary-General (A/3435) of 7 December 1956.

<u>Noting with grave concern</u> that there has not been a reply to the latest appeal of the General Assembly for the admission of United Nations observers to Hungary as contained in its resolution of 5 December 1956,

<u>Considering</u> that recent events have clearly demonstrated the will of the Eungarian people to recover their liberty and independence,

Noting the overwhelming demand of the Hungarian people for the cessation of intervention of foreign armed forces and the withdrawal of foreign troops,

1. <u>Declares</u> that, by using its armed force against the Hungarian people, the Government of the Union of Soviet Socialist Republics is violating the political independence of Hungary;

2. <u>Condemns</u> the violation of the Charter by the Government of the Union of Soviet Socialist Republics in depriving Hungary of its liberty and independence and the Hungarian people of the exercise of their fundamental rights;

3. <u>Reiterates</u> its call upon the Government of the Union of Soviet Socialist Republics to desist forthwith from any form of intervention in the internal affairs of Hungary;

4. <u>Calls upon</u> the Government of the Union of Soviet Socialist Republics to make immediate arrangements for the withdrawal, under United Nations observation, of its armed forces from Hungary and to permit the re-establishment of the political independence of Hungary;

5. <u>Requests</u> the Secretary-General to take any initiative that he deems helpful in relation to the Hungarian problem in conformity with the principles of the Charter and the resolutions of the General Assembly.
