

# Allocation of agenda items to the Second Committee

## Note by the Secretariat

- 1. At the 2nd plenary meeting of its seventy-second session, held on 15 September 2017, the General Assembly took decisions pertaining to the allocation of agenda items (see A/72/252), including to the Second Committee (see annex).
