SPECIAL POLITICAL COMMITTEENote by the Chairman

1. By a letter dated 20 September 1991 (A/SPC/46/1) the President of the General Assembly informed the Chairman of the Special Political Committee of the allocation of agenda items to the Special Political Committee.
2. The Chairman has prepared the following tentative timetable for the work of the Committee. The schedule will have to be interpreted with the necessary degree of flexibility. At the appropriate stage, the Committee will have to carry out the decisions of the General Assembly that organizations having a special interest in item 37 (Policies of apartheid of the Government of South Africa) would be permitted to be heard by the Special Political Committee.
