JOINT COMMUNIQUÉ

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN

THE REPUBLIC OF KENYA AND

THE KINGDOM OF CAMBODIA

The Government of the Republic of Kenya and the Royal Government of Cambodia. guided by the mutual willingness to develop and strengthen the ties of friendship and cooperation, have decided to establish diplomatic relations.

Both Parties agree to establish their diplomatic relations in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18th April 1961, the United Nations Charter and relevant principles and norms of international law.

The Republic of Kenya and the Kingdom of Cambodia are fully convinced that the establishment of the diplomatic relations correspond with their mutual interest and will further strengthen international peace and security.

Both countries agree to promote their bilateral dialogue through their diplomatic missions to the United Nations as well as other convenient diplomatic channels.

In the witness whereof, the undersigned representatives, duly authorized by their respective Governments, have signed this Joint Communiqué in two originals in the English and Khmer language, both texts being equally authentic.
