# Election of five members of the Committee on Enforced Disappearances to replace those whose terms are due to expire on 30 June 2017


# Note by the Secretary-General

1. In accordance with article 26 of the International Convention for the Protection of All Persons from Enforced Disappearance, the fourth meeting of the States parties to the Convention is to be held at United Nations Headquarters on Tuesday, 20 June 2017, for the purpose of electing five members of the Committee on Enforced Disappearances from a list of persons nominated by States parties from among their nationals (sect. II) to replace those whose terms are due to expire on 30 June 2017 (sect. I). Five members will continue to serve on the Committee until 30 June 2019 (sect. III).

2. In compliance with paragraph 12 of General Assembly resolution 68/268, the present note contains information on the current situation with respect to the composition of the Committee on Enforced Disappearances, reflecting the balance in terms of geographical distribution and gender representation, professional background and different legal systems, as well as the tenure of current members (sects. I and II). The biographical data of current members can be found on the web of the Committee page (www.ohchr.org/EN/HRBodies/CED/Pages/Membership.aspx).

3. In paragraph 13 of its resolution 68/268, the Assembly encouraged States parties, in the election of treaty body experts, to give due consideration, as stipulated in the relevant human rights instruments, to equitable geographical distribution, the representation of the different forms of civilization and the principal legal systems, balanced gender representation and the participation of experts with disabilities in the membership of the human rights treaty bodies.

In 2011 and in the wake of the Revolution (January 2011), as Director General for International Organizations and Conferences at the Tunisian Ministry of Foreign Affairs, I was the main interlocutor with the human rights bodies of the United Nations. In this regard, I led the team that laid the groundwork for the ratification by Tunisia of six international human rights treaties, including the International Convention for the Protection of All Persons from Enforced Disappearance. The team developed a statement of reasons for acceding to such a convention, thereby resulting in the initiation of the ratification process by the Government in February 2011 and notification of ratification in June 2011. The team also negotiated the headquarters agreement for the opening in Tunis of a country office of the Office of the United Nations High Commissioner for Human Rights. In addition, it extended a standing invitation to the Special Rapporteurs in a statement made at the high-level segment of the Human Rights Council in February 2011. I represented Tunisia on the Human Rights Council between September 2011 and April 2013. Since September 2013, I have taught human rights at the Diplomatic Institute of Tunis.
