ON THE ESTABLISHMENT OF
DIPLOMATIC RELATIONS
BETWEEN

Desirous of developing and strengthening relations of friendship and mutual cooperation between the two countries in accordance with the purposes and principles of the United Nations Charter and the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961:

Jamaica and the Republic of The Gambia have agreed to establish diplomatic relations between the two countries at the Ambassadorial level as of 29th November, 2011.
