









# THE ESCWA STATISTICS DIVISION WORK PROGRAMME FOR THE YEARS 1998 AND 1999

#### I. OVERVIEW AND SUMMARY OF ACTIVITIES

- 1. The work programme of the ESCWA Statistics Division will provide support to member States in harmonizing statistics and information. It will contribute to the development of national statistical systems and to their harmonization on a regional and international basis. It will also establish and develop regional statistical databases and information systems in line with the role of ESCWA as the major regional source of statistics and information.
- 2. Through data collection and processing, meetings, technical assistance, human and institutional capacity-building, the work programme will establish and expand sectoral databases in the area of economic and social statistics and embark on the preparatory phase of establishing a regional statistical information system. It will further promote international concepts, standards and classifications and will implement international systems and programmes, mainly the 1993 System of National Accounts and the 2000 Round of Population and Housing Censuses. It will assist national statistical departments in the collection of specific indicators and statistics required for the follow-up of the recent global conferences and it will also provide assistance to member States in the areas of gender statistics and the International Comparison Programme.
- 3. Improved documentation and substantive servicing of the ESCWA biennial Commission session and the third session of the ESCWA Statistical Committee will contribute to the adoption of the proposed statistical standards. Inputs will be provided for the documentation required for the Statistical Commission. Joint activities will be expanded with the United Nations bodies responsible for statistics and information as well as other relevant international organizations. Cooperation will continue with the League of Arab States (LAS) and its specialized organizations as well as with other relevant international organizations.
- 4. This work programme will continue to deal with the same areas as the previous biennium owing to the recurrent nature of the activities. However, in comparison with the previous biennium, the programme will be more involved in the execution of regional projects in newly emerging areas such as gender statistics. It will give greater emphasis to new dimensions in social statistics to facilitate the monitoring of implementation of the recommendations of the global conferences of the United Nations.

#### II. ACTIVITIES
