رسالة مؤرخة ٢ تشرين الأول/أكتوبر ٢٠١٧ موجهة إلى الأمين العام من الممثلة  
الدائمة لسانت فنسنت وجزر غرينادين لدى الأمم المتحدة

يشرفني أن أكتب إليكم بالنيابة عن مجموعة مقدمي مشروع القرار L.69، وهي مجموعة متنوعة من البلدان تتألف في معظمها من دول صغيرة تقع في أفريقيا وأمريكا اللاتينية ومنطقة البحر الكاريبي وآسيا ومنطقة المحيط الهادئ وتوحدّها قضية مشتركة ألا وهي تحقيق إصلاح دائم وشامل لمجلس الأمن في الأمم المتحدة.

فأثناء المفاوضات الحكومية الدولية التي جرت في الدورة الحادية والسبعين بشأن إصلاح مجلس الأمن، أدلت مجموعة مقدمي مشروع القرار L.69 بالتفاصيل الكاملة لما أكدناه من أن ١٨٣ دولة عضوا قد شاركت في المفاوضات الحكومية الدولية المتعلقة بإصلاح مجلس الأمن أو في المناقشة التي أجرتها الجمعية العامة بهذا الشأن، وأن ١٦٤ دولة عضوا دعت، منذ عام ٢٠٠٩، إلى صياغة نص يُتخذ أساساً للمفاوضات (انظر المرفقين الأول والثاني).

وأرجو التفضل بتعميم هذه الرسالة ومرفقيها باعتبارها وثيقة رسمية من وثائق الجمعية العامة في إطار بند جدول الأعمال ١٢٢ بشأن مسألة التمثيل العادل في مجلس الأمن وزيادة عدد أعضائه والمسائل الأخرى المتصلة بمجلس الأمن.

## المرفق الأول للرسالة المؤرخة ٢ تشرين الأول/أكتوبر ٢٠١٧ الموجهة إلى الأمين العام من الممثلة الدائمة لسنت فنسنت وجزر غرينادين لدى الأمم المتحدة<sup>(١)</sup>

قائمة الدول الأعضاء التي شاركت في المفاوضات الحكومية الدولية، أو التي أدلت في الجمعية العامة ببيانات رسمية بشأن موضوع إصلاح مجلس الأمن، منذ بداية المفاوضات الحكومية الدولية في عام ٢٠٠٩

استنادا إلى البيانات التي أدلى بها في الجمعية العامة وإلى المفاوضات الحكومية الدولية والمساهمات التي قُدمت في الوثيقة الإطارية ومرفقها، نؤكد أن ما عدده ١٨٣ دولة عضوا شاركت مشاركة نشطة في عملية المفاوضات الحكومية الدولية منذ بدايتها.

وقد تبيننا وجود بيانات بشأن إصلاح مجلس الأمن (منذ بدء المفاوضات الحكومية الدولية في عام ٢٠٠٩) لجميع الدول الأعضاء، باستثناء الدول الأعضاء العشر التالية: أذربيجان وإسرائيل وألبانيا وأندورا وأوزبكستان وتركمانستان وجمهورية مقدونيا اليوغوسلافية سابقا وطاجيكستان وقيرغيزستان وهندوراس.

ومن المهم الإشارة إلى أن سبعا من هذه الدول الأعضاء العشر قد شاركت، في الواقع، في عملية المفاوضات الحكومية الدولية، وإن لم تكن تلك المشاركة بواسطة بيانات يمكن العثور عليها، ولكن بالأحرى من خلال توقيع الرسالة التي وجهت في عام ٢٠٠٩ إلى سفير أفغانستان، ظاهر تانين، رئيس المفاوضات الحكومية الدولية آنخذ. ففي تلك الرسالة طلبت منه الدول الأعضاء أن يقدم "نصا يحتوي على خيارات تتخذ أساسا للمفاوضات". وهذه الدول الأعضاء السبع هي: أندورا وأوزبكستان وتركمانستان وجمهورية مقدونيا اليوغوسلافية سابقا وطاجيكستان وقيرغيزستان وهندوراس. وبذلك لم يبق سوى ٣ دول أعضاء لم يعثر لها على سجل يثبت مشاركتها، وهي أذربيجان وإسرائيل وألبانيا.

وإذا أخذت هذه الدول الأعضاء السبع بعين الاعتبار، فإن عدد البلدان التي تكون قد انخرطت في هذا المسار منذ بداية المفاوضات الحكومية الدولية هو في الواقع ١٩٠ بلدا.

وترد فيما يلي القائمة الكاملة بأسماء ١٨٣ بلدا، متضمنة تفاصيل تتعلق ببيانات تلك البلدان أمام الجلسة العامة للجمعية العامة واجتماعات المفاوضات الحكومية الدولية ومساهماتها في الوثيقة الإطارية (انظر الملحق).

عدد الدول الأعضاء التي دعت إلى نص يتخذ أساسا للمفاوضات منذ بداية المفاوضات الحكومية الدولية في عام ٢٠٠٩

بناء على العملية الحسابية التي أجريناها، فإن ١٦٤ بلدا تؤيد وضع نص يتخذ أساسا للمفاوضات.

ففي ٢٣ كانون الأول/ديسمبر ٢٠٠٩، كتب ما عدده ١٣٨ بلدا إلى رئيس المفاوضات الحكومية الدولية وطلبت منه إعداد نص يتضمن خيارات ويتخذ أساسا للمفاوضات.

وقد ثبت رسميا أن المجموعة الأفريقية دعت إلى إجراء مفاوضات تستند إلى نص، وذلك من خلال لجنة رؤساء الدول والحكومات العشرة (لجنة الرؤساء العشرة) التابعة للاتحاد الأفريقي. ولذلك، فإننا قد أضفنا البلدان العشرين التالية من المجموعة الأفريقية، وهي بلدان لا تدرج ضمن قائمة البلدان الـ ١٣٨ التي وقعت الرسالة، إلى عدد الدول الأعضاء التي دعت إلى مفاوضات استنادا إلى نص، وبذلك يرتفع العدد إلى ١٥٨ بلدا، وهي: إريتريا وبوركينا فاسو وتشاد والجزائر وجمهورية الكونغو الديمقراطية وجنوب السودان وجيبوتي وسان تومي وبرينسيبي والسنغال وسيراليون وغينيا الاستوائية والكاميرون والكونغو وكينيا وليبيا ومالي ومصر والمغرب وناميبيا والنيجر.

وبالإضافة إلى ذلك، تثبت السجلات أن كيريباس، وهي دولة جزرية صغيرة نامية في منطقة البحر الهادئ، وهولندا، وهي عضو في مجموعة بينيلوكس، وكذلك أفغانستان وبنما والسويد ونيوزيلندا، معروف عنها أنها تدعم المفاوضات استنادا إلى نص، كما أنها لم تدرج في الرسالة المؤرخة ٢٣ كانون الأول/ديسمبر ٢٠٠٩.

ومن ثم فإننا لا نجازف إذا قلنا إن ما مجموعه ١٦٤ دولة عضوا تؤيد الشروع في مفاوضات استنادا إلى نص.
