



JOINT COMMUNIQUÉ

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF ARMENIA AND THE REPUBLIC OF HONDURAS

The Government of the Republic of Armenia and the Government of the Republic of Honduras;

In order to promote mutual understanding and strengthening the friendship and cooperation between the two countries;

Guided by the principles and purposes enshrined in the Charter of the United Nations and the principles of international law;

Have decided to establish diplomatic relations in accordance with the provisions of the Vienna Convention on Diplomatic Relations of the 18th of April 1961, as of the signing of this Joint Communiqué;

In witness thereof, the undersigned representatives, duly authorized by their respective Governments, have signed this Joint Communiqué in two duplicates, in Armenian, Spanish and English languages, the three texts being equally authentic.

Done at New York, 16th of September 2011.



COMUNICADO CONJUNTO

SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMATICAS ENTRE LA REPUBLICA DE ARMENIA Y LA REPUBLICA DE HONDURAS

El Gobierno de la República de Armenia y el Gobierno de la República de Honduras,

Con el propósito de promover el entendimiento mutuo y fortalecer la amistad y cooperación entre ambos países,

Guiados por los principios y propósitos enmarcados en la Carta de las Naciones Unidas y los principios de la Ley Internacional;

Han decidido establecer relaciones diplomáticas en concordancia con las disposiciones de la Convención de Viena sobre Relaciones Diplomáticas del 18 de abril de 1961, a partir de la firma de este Comunicado Conjunto;
