Addendum

1. In accordance with article 8 of the International Convention on the Elimination of All Forms of Racial Discrimination, the twenty-seventh meeting of States parties to the Convention is to be held at United Nations Headquarters on 22 June 2017 for the purpose of electing nine members of the Committee on the Elimination of Racial Discrimination to replace those whose terms will expire on 19 January 2018.
