Addendum

The following letter was received by the Secretary-General on 27 July 1972:

On the instructions of our Governments we support the request of the 13 countries, dated 17 July 1972, to include in the provisional agenda of the twenty-seventh session of the General Assembly the item entitled "C sation of favourable conditions to accelerate the independent and peaceful reunification of Korea" (A/8752 and Corr.1).

Our Governments share just demands of the Democratic People's Republic of Korea and other States to put an end to outside interference into the affairs of the Korean people, to withdraw the United States forces from South Korea and to dissolve the United Nations Commission for the Unification and Rehabilitation of Korea.

In accordance with this we ask you to add our signatures to the request of the 13 States to include a new item in the provisional agenda of the twenty-seventh session of the General Assembly.
