UNITED NATIONS INDUSTRIAL DEVELOPMENT ORGANIZATION

Report of the Second Committee

Rapporteur: Mr. Salih Mohammed OSMAN (Sudan)

1. The General Assembly, at its 1939th plenary meeting, on 25 September 1971, allocated to the Second Committee agenda item 42, entitled "United Nations Industrial Development Organization:

"(a) Report of the Industrial Development Board;

"(b) Report of the Special International Conference of the United Nations Development Organization."

2. The Second Committee considered this item at its 1411th to 1413th meetings between 17 and 19 November 1971, at its 1417th and 1421st meetings on 24 and 26 November 1971, at its 1428th and 1429th meetings on 3 December 1971, at its 1431st and 1432nd meetings on 6 and 7 December 1971. An account of the discussions of the Committee on this item is contained in the relevant summary records.^{1/} At its 1411th meeting, on 17 November 1971, the Committee heard an introductory statement by the President of the Industrial Development Board as well as by the Executive Director of the United Nations Industrial Development Organization.

3. When considering the item, the Committee had before it a note by the Secretary-General (A/8385), the report of the Industrial Development Board on

its fifth session, the report of the Special International Conference of the United Nations Industrial Development Organization (A/8341) and the relevant part of the report of the Economic and Social Council to the General Assembly.^{2/}

4. The Committee had before it two draft resolutions, as set forth in sections I and II below.

I

5. At the 1412th meeting, on 18 November 1971, the representative of Brazil on behalf of the delegations of Brazil, Chile, Peru, the Philippines and Venezuela, introduced a draft resolution (A/C.2/L.1183), entitled "Report of the Special International Conference of the United Nations Industrial Development Organization", which read as follows:

"The General Assembly,

"Recalling its resolution 2638 (XXV) of 19 November 1970 which convened the Special International Conference of the United Nations Industrial Development Organization to deal with the long-range strategy and orientation of the United Nations Industrial Development Organization's activities, including the Organization's role in the Second Development Decade and the transfer and adaptation of technology for the industrial development of the developing countries; the organizational structure of UNIDO; and questions of UNIDO's financing,

"Bearing in mind the leading role of industrialization in the economic and social progress of the developing countries, as well as the central role and the responsibility of UNIDO in reviewing and promoting the co-ordination of all activities of the United Nations system in the field of industrial development, as established in paragraph 27 of General Assembly resolution 2152 (XXI),

"Convinced that the successful achievement of the tasks assigned to UNIDO in the field of promoting the industrialization of the developing countries, in connexion with the International Development Strategy, is only possible if the efforts and resources of that organization and the resources of other appropriate organizations of the United Nations system are concentrated on priorities indicated in a clearly defined long-term strategy for UNIDO's activities,

"Taking note of Economic and Social Council resolution 1635 (LI) of 30 July 1971, which transmits the report of the Special International Conference of the United Nations Industrial Development Organization, together with the comments of delegations, to the General Assembly at its twenty-sixth session,

"1. Endorses resolution ID/SCU/RES.1 of the Special International Conference of the United Nations Development Organization and takes note of the views of member States as expressed in its report (A/8341);

"2. Commends the guidelines contained in part I of resolution ID/SCU/Res.1 as an adequate framework for drafting the long-range strategy of the activities of the United Nations Industrial Development Organization;

"3. Requests the Secretary-General of the United Nations to take immediate action to appoint a small group of high-level experts from the various geographical groups, chosen in consultation with their respective Governments, to carry out the important task of formulating, in accordance with the guidelines set out in part I of resolution ID/SCU/Res.1, the long-range strategy for the activities of UNIDO, and to submit their final report to the Industrial Development Board at its sixth session;

"4. Requests the Industrial Development Board to propose to the General Assembly, in due time, the necessary measures to convene another general conference of UNIDO in 1974 or 1975, as appropriate, and to recommend its provisional agenda keeping in mind the need to review the progress of industrialization during the Second Development Decade;

"5. Considers desirable that the United Nations Industrial Development Organization should have greater autonomy in all administrative matters, including those of recruitment of personnel and management of its publications programme;

"6. Expresses satisfaction for the initiative taken by the Economic and Social Council in its resolution 1617 (LI) of 27 July 1971, in order to ensure that special attention is given by the Administrator of the United Nations Development Programme to the requests for development assistance made in the field of industrial development, in particular by the least developed among the developing countries and including industrial technological development and industrial pilot projects;

"7. Urges the Governing Council of the United Nations Development Programme to plan the level of the programme reserve of the Programme in such a way that a minimum of \$2 million is retained annually for financing the Special Industrial Services programme, and that additional resources be provided in the light of future requirements;

"8. Requests the Governing Council and the Administrator of the UNDP to renew efforts in order to ensure that, within the allocated percentage of resources provided for in paragraph 26 of the annex to resolution 2688 (XXV), maximum possible utilization of regional, subregional and global projects be made in order to provide developing countries with the industrial infrastructure and know-how necessary for conditions of sustained and independent economic development;

"9. Calls on the United Nations Industrial Development Organization to assist, in co-operation with the United Nations Conference on Trade and Development and with the regional economic commissions and the United Nations Economic and Social Office at Beirut, the developing countries, especially the least developed among them, to take full advantage of the benefits of the general system of preferences for manufactures and semi-manufactures;

"10. Recommends that, as part of the preparatory work for the next general conference of UNIDO, the Industrial Development Board keep under consideration the proposals submitted to the Special International Conference on such changes and improvements as might be necessary, pursuant to paragraph 37 of General Assembly resolution 2152 (XXI), in order to meet fully the growing needs in the field of industrial development."

6. At the same meeting, in response to requests made by some representatives, the Executive Director of UNIDO stated that a corrigendum to the report of the Special International Conference of UNIDO would be issued.

7. At the 1413th meeting, on 19 November 1971, the representative of Nigeria introduced amendments (A/C.2/L.1186) to the draft resolution which provided for:

- (a) The deletion of paragraph 1;
- (b) The replacement of paragraph 4 by the following text:

"4. Decides to convene another general conference of the United Nations Industrial Development Organization in 1973 to consider the results of the Special International Conference and especially to review progress in the industrial sector within the context of the over-all biennial review of progress in the implementation of the objectives and policies of the international development strategy;"

(c) The addition of the following new operative paragraph after the existing paragraph 8:

"Requests the Industrial Development Board to set up an ad hoc committee to examine in detail all aspects of UNDP-UNIDO co-operation especially those related to the formulation, appraisal and approval of industrial projects. The ad hoc committee should be composed of representatives of the Governing Council of the United Nations Development Programme and of the Bureau of the Industrial Development Board with the participation of the Administrator and the Executive Director of the two bodies. The ad hoc committee will submit its report to the General Assembly at its twenty-eighth session through the Governing Council and the Industrial Development Board;"

(d) The addition of the following new operative paragraph after the existing paragraph 9:

"Invites the Executive Director of the United Nations Industrial Development Organization to extend full co-operation to regional conferences of ministers of industry held under the auspices of the regional economic commissions in order to facilitate greater regional co-ordination of industrial development policies;"

8. At the same meeting the representative of Brazil, on behalf of the delegations of Bolivia, Brazil, Chile, Colombia, Panama, Peru, the Philippines, Uruguay and Venezuela, introduced a revision to the draft resolution (A/C.2/L.1183/Rev.1). The revised text included the following changes:

(a) In the third paragraph of the preamble, the phrase "entrusted with the financing of industrial development" was inserted after the words "other appropriate organizations of the United Nations system";

(b) In the fourth paragraph of the preamble, the words "which transmits" were substituted by the words "by which the Council transmitted";

(c) In paragraph 2, the words "the paragraphs of" were inserted between the words "in" and "part";

(d) A new operative paragraph 5 was introduced, as proposed by the representative of Colombia at the 1412th meeting, on 18 November 1971, which read as follows:

"5. Recommends that the Industrial Development Board, at its sixth session, take action in accordance with paragraph 10, part II, of resolution ID/SCU/Res.1, and set up as its subsidiary organ a permanent Committee of the Board with the terms of reference established therein;"

(e) In new paragraph 7, the words "in accordance with the priorities assigned by the developing countries" were inserted after the words "Administrator of the United Nations Development Programme";

(f) In new paragraph 8, the words "may be" were replaced by the word "is" before the words "retained annually";

(g) New paragraph 9 was reworded to read as follows:

"9. Requests the Administrator of the United Nations Development Programme to give, among the global projects mentioned in paragraphs 21 to 26 of the consensus adopted by the Governing Council of UNDP at its tenth session in June 1970, particular attention to projects within the sphere of industrial technological development;"

9. At the same meeting, the following amendments were introduced:

(a) The representative of Kuwait, also on behalf of the Syrian Arab Republic, proposed the addition of the following new operative paragraph (A/C.2/L.1188) after paragraph 9:

"Requests the Secretary-General to establish an ad hoc intergovernmental committee composed of representatives of the Governing Council of the United Nations Development Programme and of the Industrial Development Board to examine, in consultation with the Administrator of the United Nations Development Programme and the Executive Director of the United Nations Industrial Development Organization, all aspects of co-operation between UNIDO and UNDP and report to the General Assembly at its twenty-seventh session through the Economic and Social Council;"

(b) The representative of Sweden proposed the addition of the following new operative paragraph (A/C.2/L.1192) after paragraph 4:

"Invites the Industrial Development Board and the Executive Director of the United Nations Industrial Development Organization to consider and keep under review the organization and the structure of the UNIDO secretariat, with a view to adapting it to the needs of the work programme and, in particular, the need for an effective implementation of the existing operational activities;"

10. At the same meeting, following a request made by some representatives, who objected to the issuance of a corrigendum by the Secretary-General to the report of the Special International Conference of UNIDO which, in their view, was of substantive nature, the representative of the Office of Legal Affairs made a statement.

11. A statement by the Secretary-General regarding the administrative and financial implications of the revised draft resolution was before the Committee (A/C.2/L.1191).

12. At the 1417th meeting, on 24 November 1971, the Committee had before it a further revision of the draft resolution (A/C.2/L.1183/Rev.2), which incorporated the following changes:

(a) The addition of a new paragraph of the preamble at the end of the preambular part, which read as follows:

"Taking note of the report of the Industrial Development Board on its fifth session (A/8416),";

(b) The replacement of the words "at its sixth session" by the words "as soon as possible and, at any rate, in time for consideration at its seventh session" at the end of paragraph 3;

(c) The addition of a new operative paragraph 10 as proposed in the two-Power amendment (A/C.2/L.1188) (see paragraph 9 (a) above).

13. At the 1421st meeting, on 26 November 1971, the representative of Chile submitted to the Committee the amendments mentioned below to the revised draft resolution, as constituting the agreement reached among the delegations who actively participated in the debate on the question of the consensus contained in the report of the Special International Conference of UNIDO, on the clear understanding that the Secretariat would issue a revised version of document A/8431, as corrected (A/8431/Corr.1). These amendments were accepted by the sponsors and were incorporated in document A/C.2/L.1183/Rev.3. They called for:

(a) The replacement of paragraph 1 by the following text:

"1. Endorses resolution ID/SCU/Res.1 of the Special International Conference of the United Nations Development Organization and takes note of the report of the Special International Conference of UNIDO (A/8431) and the views of Member States contained in it, as well as of A/8431/Corr.1 and the views expressed thereon;"

(b) The addition of a new operative paragraph after paragraph 11, which read as follows:

"12. Invites the Executive Director of the United Nations Industrial Development Organization to review the organization and the structure of the UNIDO secretariat, with a view to adapting it to the changing needs of the work programme in the light of the Strategy and, in particular, to the needs of the work programme in the light of the Strategy and, in particular, to the needs for effective implementation of the operational activities of the Organization, and to submit appropriate reports and proposals thereon to the Industrial Development Board;"

14. At the 1428th meeting, on 3 December 1971, the representative of Brazil, on behalf of the delegations of Bolivia, Brazil, Chile, Colombia, Ghana, Iran, Kuwait, Panama, Peru, the Philippines, the Sudan, the Upper Volta, Uruguay and Venezuela, introduced a revised text (A/C.2/L.1183/Rev.4) of the revised draft resolution, which incorporated the following changes:

/...

- (a) In paragraph 3, the words "bearing in mind the one referring to special consideration of the industrialization needs of the least developed among the developing countries" were inserted after the symbol "ID/SCU/Res.1"; and
- (b) Paragraph 10 was reworded as follows:

"10. Decides to establish an ad hoc intergovernmental committee composed of 20 members, half of which to be selected from among the members of the Governing Council of the United Nations Development Programme and the other half from among the members of the Industrial Development Board; requests the President of the General Assembly to hold consultations with the President of the Governing Council of the United Nations Development Programme and the President of the Industrial Development Board for the purpose of selecting the 20 members; instructs the ad hoc intergovernmental committee to examine all aspects of co-operation between the United Nations Development Programme and the United Nations Industrial Development Organization and to submit a report on the means of improving the existing co-operation between them to the General Assembly at its twenty-seventh session, through the Economic and Social Council; requests the Secretary-General of the United Nations to convene the ad hoc intergovernmental committee at an early date and to extend to it all necessary facilities and assistance".

15. In introducing the revised draft resolution, the representative of Brazil, on behalf of the sponsors, orally further revised the text by:

(a) Inserting, in paragraph 10, after the words "to examine" in the eighth line, the words "in consultation with the Executive Director of UNIDO and the Administrator of UNDP";

(b) Replacing the word "submit" in the tenth line of paragraph 10, by the word "prepare";

(c) Inserting in the same paragraph the words "along with the views of the Industrial Development Board and the Governing Council of the UNDP thereon" after the words "through the Economic and Social Council";

(d) Adding the words "in New York" after the words "early date" in the last line of paragraph 10.

16. At the same meeting the two-Power amendment (A/C.2/L.1188) was withdrawn.

17. At the same meeting, the representative of Nigeria orally revised his third amendment (A/C.2/L.1186) relating to paragraph 10 of the draft resolution (A/C.2/L.1183/Rev.4) to read as follows:

"10. Requests the Secretary-General to convene an ad hoc committee to examine in detail all aspects of UNDP/UNIDO co-operation, especially those related to the formulation, appraisal and approval of industrial projects. The ad hoc committee should be composed of the Bureaux of the Governing Council of the UNDP and the Industrial Development Board with the participation of the Administrator and the Executive Director of the two bodies. The report of the ad hoc committee should be submitted to the General Assembly at its twenty-eighth session together with the comments of the Governing Council and the Industrial Development Board".

18. Also at the same meeting, the amendment of Sweden (A/C.2/L.1192) was withdrawn.

19. At the same meeting, the representative of Finland, on behalf of the delegations of Canada, Denmark, Finland, Greece, Iceland, Norway, Sweden, the United Kingdom of Great Britain and Northern Ireland and the United States of America, introduced an amendment (A/C.2/L.1207) which called for the replacement of the existing paragraph 10 by the following text:

"10. Requests the Administrator of the United Nations Development Programme and the Executive Director of the United Nations Industrial Development Organization to examine jointly all aspects of co-operation between UNDP and UNIDO and to submit a report thereon through the Governing Council of the United Nations Development Programme, the Industrial Development Board and the Economic and Social Council to the General Assembly at its twenty-seventh session;"

20. At the 1431st meeting, on 6 December 1971, the representative of Kuwait, on behalf of the sponsors, orally revised the revised draft resolution (A/C.2/L.1183/Rev.4) by:

(a) Deleting the word "all" in paragraph 6;

(b) Adding the words "based on demonstrated needs" at the end of paragraph 8;

(c) Inserting between paragraphs 9 and 10, a new paragraph 10, which was the fourth of the Nigerian amendments (A/C.2/L.1186), reworded as follows:

"10. Invites the Executive Director of the United Nations Industrial Development Organization to extend full co-operation to regional industrial conferences held at ministerial or other levels under the auspices of the regional economic commissions and the United Nations Economic and Social Office in Beirut in order to facilitate greater regional co-ordination of industrial development policies;"

(d) Rewording former paragraph 10 as follows:

"11. Decides to set up an ad hoc intergovernmental committee composed of those member States whose representatives currently serve on the Bureaux of the Governing Council of the United Nations Development Programme and the Industrial Development Board to examine in detail, in consultation with the Administrator of the United Nations Development Programme and the Executive Director of the United Nations Industrial Development Organization, all aspects of UNDP-UNIDO co-operation especially those related to the formulation, appraisal and approval of industrial projects and to submit a report thereon to the General Assembly at its twenty-seventh session, through the Economic and Social Council, together with the comments of the Governing Council of the United Nations Development Programme and the Industrial Development Board;"

(e) Placing the last sentence in former paragraph 10 as a new paragraph 12, reworded as follows:

"12. Requests the Secretary-General of the United Nations to convene the ad hoc intergovernmental committee at an early date in New York and to extend to it all necessary facilities and assistance;"

21. At the same meeting, the representative of Nigeria withdrew his amendments (A/C.2/L.1186) and joined in sponsoring the revised draft resolution.

22. At the 1432nd meeting, on 7 December 1971, the Committee had before it a revised draft resolution (A/C.2/L.1183/Rev.5), which included the changes made at the previous meeting.

23. At the same meeting, the Committee voted on the revised draft resolution (A/C.2/L.1183/Rev.5) and the amendment thereto as follows:

(a) It rejected by 41 votes to 24, with 17 abstentions, the nine-Power amendment relating to the replacement of paragraphs 11 and 12 by the text contained in document A/C.2/L.1207;

(b) On a separate vote, requested by the representative of Finland it adopted paragraphs 11 and 12 of the revised draft resolution by a vote of 57 to none, with 32 abstentions;

(c) On a separate vote, requested by the representative of the Union of Soviet Socialist Republics, it adopted paragraph 15 of the revised draft resolution by 82 votes to none, with 10 abstentions;

(d) It adopted unanimously the revised draft resolution, as a whole, by 97 votes to none (see para. 25, draft resolution I).

24. At its 1432nd meeting, on 7 December 1971, the Committee adopted, without objection, a draft resolution suggested by the Chairman, by which the General Assembly would decide to include Bahrain, Bhutan, Oman and Qatar in list A of the annex to its resolution 2152 (XXI) (see para. 25, draft resolution II).

RECOMMENDATIONS OF THE SECOND COMMITTEE

25. The Second Committee recommends to the General Assembly the adoption of the following draft resolutions:

DRAFT RESOLUTION I

Report of the Special International Conference of the United Nations Industrial Development Organization

The General Assembly,

Recalling its resolution 2638 (XXV) of 19 November 1970 in which it convened the Special International Conference of the United Nations Industrial Development Organization to deal with the long-range strategy and orientation of that Organization's activities, including its role in the Second United Nations Development Decade and the transfer and adaptation of technology for the industrial development of the developing countries, the organizational structure of the United Nations Industrial Development Organization and questions of its financing,

Bearing in mind the leading role of industrialization in the economic and social progress of the developing countries, as well as the central role, and the responsibility of the United Nations Industrial Development Organization in reviewing and promoting the co-ordination of all activities of the United Nations system in the field of industrial development, as established in paragraph 27 of General Assembly resolution 2152 (XXI) of 17 November 1966,

Convinced that the successful achievement of the tasks assigned to the United Nations Industrial Development Organization in the field of promoting the industrialization of the developing countries, in connexion with the International Development Strategy for the Second United Nations Development Decade, contained in General Assembly resolution 2626 (XXV) of 19 November 1970, is only possible if the efforts and resources of that Organization and the resources of other appropriate organizations of the United Nations system entrusted with the financing of industrial development are concentrated on priorities indicated in a clearly defined long-term strategy for its activities,

Taking note of Economic and Social Council resolution 1635 (LI) of 30 July 1971, by which the Council transmitted the report of the Special International Conference of the United Nations Industrial Development Organization,^{3/} together with the comments of delegations, to the General Assembly at its twenty-sixth session,

Taking note of the report of the Industrial Development Board on its fifth session,^{4/}

1. Endorses the resolution of consensus on long-range strategy, structure and financing of the United Nations Industrial Development Organization, adopted by the Special International Conference of the United Nations Industrial Development Organization on 8 June 1971,^{5/} and takes note of the report of the Conference and the views of Member States contained in it, and also the views expressed thereon;

2. Commends the guidelines contained in the paragraphs of section I of the resolution as an adequate framework for drafting the long-range strategy of the activities of the United Nations Industrial Development Organization;

3. Requests the Secretary-General of the United Nations to take immediate action to appoint a small group of high-level experts from the various geographical groups, chosen in consultation with their respective Governments, to carry out the important task of formulating, in accordance with the guidelines set out in section I of the above-mentioned resolution, bearing in mind the one referring to special consideration of the industrialization needs of the least developed among the developing countries, the long-range strategy for the activities of the United Nations Industrial Development Organization, and to submit their final report to the Industrial Development Board as soon as possible and, at any rate, in time for consideration at its seventh session;

4. Requests the Industrial Development Board to propose to the General Assembly, in due time, the necessary measures for convening another general conference of the United Nations Industrial Development Organization in 1974 or 1975, as appropriate, and to make recommendations for a provisional agenda keeping in mind the need to review the progress of industrialization during the Second United Nations Development Decade;

5. Recommends that the Industrial Development Board, at its sixth session, should take action in accordance with paragraph 10, section II, of the resolution of consensus and set up as its subsidiary organ a permanent committee of the Board with the terms of reference established therein;

6. Considers it desirable that the United Nations Industrial Development Organization should have greater autonomy in administrative matters, including the recruitment of personnel and management of its publications programme;

7. Expresses its satisfaction at the initiative taken by the Economic and Social Council, in its resolution 1617 (LI) of 27 July 1971, to ensure that special attention should be given by the Administrator of the United Nations Development Programme, in accordance with the priorities assigned by the developing countries, to the requests for development assistance made in the field of industrial development, in particular by the least developed among the developing countries and including industrial technological development and industrial pilot projects;

8. Urges the Governing Council of the United Nations Development Programme to plan the level of the programme reserve of the Programme in such a way that a minimum of \$2 million may be retained annually for financing the Special Industrial Services programme, and that additional resources be provided in the light of future requirements based on demonstrated needs;

9. Requests the Administrator of the United Nations Development Programme to give, among the global projects mentioned in paragraphs 21 to 26 of the consensus adopted by the Governing Council of the Programme at its tenth session,^{6/} in June 1970, particular attention to projects within the sphere of industrial technological development;

10. Invites the Executive Director of the United Nations Industrial Development Organization to extend full co-operation to regional industrial conferences held at ministerial or other levels under the auspices of the regional economic commissions and the United Nations Economic and Social Office at Beirut in order to facilitate greater regional co-ordination of industrial development policies;

11. Decides to set up an ad hoc intergovernmental committee composed of those Member States whose representatives are currently serving on the bureaux of the Governing Council of the United Nations Development Programme and the Industrial Development Board to examine in detail, in consultation with the

Administrator of the United Nations Development Programme and the Executive Director of the United Nations Industrial Development Organization, all aspects of co-operation between the two organizations, especially those related to the formulation, appraisal and approval of industrial projects, and to submit a report thereon to the General Assembly at its twenty-seventh session, through the Economic and Social Council, together with the comments of the Governing Council of the Programme and those of the Industrial Development Board;

12. Requests the Secretary-General of the United Nations to convene the ad hoc intergovernmental committee at an early date in New York and to extend to it all the necessary facilities and assistance;

13. Calls upon the United Nations Industrial Development Organization, in co-operation with the United Nations Conference on Trade and Development and with the regional economic commissions and with the United Nations Economic and Social Office at Beirut, to assist the developing countries, especially the least developed among them, to take full advantage of the benefits of the general system of preferences for manufactures and semi-manufactures;

14. Invites the Executive Director of the United Nations Industrial Development Organization to review the organization and the structure of its secretariat, with a view to adapting it to the changing needs of the work programme in the light of the International Development Strategy and, in particular, to the needs for effective implementation of the operational activities of the organization, and to submit appropriate reports and proposals thereon to the Industrial Development Board;

15. Recommends that, as part of the preparatory work for the next general conference of the United Nations Industrial Development Organization, the Industrial Development Board should keep under consideration the proposals submitted to the Special International Conference on such changes and improvements as might be necessary, pursuant to paragraph 37 of General Assembly resolution 2152 (XXI), in order to meet fully the growing needs in the field of industrial development.

Revision of the lists of States eligible for membership
in the Industrial Development Board

The General Assembly,

Recalling section II, paragraph 4, of its resolution 2152 (XXI) of
17 November 1966 on the United Nations Industrial Development Organization,

Decides to include Bahrain, Bhutan, Oman and Qatar in list A of the annex to
General Assembly resolution 2152 (XXI).
