## I. INTRODUCTION

1. At its 199th, 200th, 201st and 202nd meetings, held on 20, 21 and 22 September 1972, the General Committee considered a memorandum by the Secretary-General relating to the organization of the twenty-seventh regular session of the General Assembly, the adoption of the agenda and the allocation of items (A/BUR/179/Rev.1).
2. A summary of the discussion will appear in the summary records of the meetings (A/BUR/SR.199 to 202).

## II. ORGANIZATION OF THE SESSION

### Schedule of meetings

3. On the proposal of the Secretary-General (A/BUR/179/Rev.1, paras. 2 and 3), the General Committee recommends to the General Assembly the following arrangements relating to the schedule of meetings:

- (a) Plenary and committee meetings should begin at 10.30 a.m. and 3 p.m.;
- (b) A five-day working week should be established, on the understanding that meetings on Saturdays, as well as night meetings, may be scheduled if necessary.

4. In this connexion, the General Committee wishes to stress the need for punctuality in opening meetings and to draw the General Assembly's attention to the amended text of rules 69 and 110 of the rules of procedure (A/520/Rev.11), whereby the President of the General Assembly may declare a meeting open and permit the debate to proceed when at least one third of the members are present, and the Chairman of a Main Committee may declare a meeting open and permit the debate to proceed when at least one quarter of the members are present.

### General debate

5. At the suggestion of the Secretary-General (A/BUR/179/Rev.1, para. 4), the General Committee wishes to draw the General Assembly's attention to the following conclusions of the Special Committee on the Rationalization of the Procedures and Organization of the General Assembly which were approved by the Assembly at its twenty-sixth session:

- (a) The length of the general debate should not normally exceed two and a half weeks (rules of procedure, annex V, para. 45);
- (b) The list of speakers wishing to take part in the general debate should be closed at the end of the third day after the opening of the debate (ibid., para. 46);
- (c) Speakers should, as far as possible, avoid putting down their names to speak on a given item and at the same time indicating an alternative meeting if they are unable to keep to their original schedule (ibid., para. 70);
- (d) Representatives should speak in the order of their inscription on the list of speakers, on the understanding that those prevented from doing so should normally be moved to the end of the list, unless they have arranged to change places with other representatives (ibid., para. 71).

6. Also at the suggestion of the Secretary-General (A/BUR/179/Rev.1, para. 5), the General Committee recommends:

- (a) That the general debate should begin on Monday, 25 September and end on Wednesday, 11 October 1972;
- (b) That the list of speakers wishing to take part in the general debate should be closed on Wednesday, 27 September, at 6 p.m.

#### Right of reply

7. At the suggestion of the Secretary-General (A/BUR/179/Rev.1, para. 6), the General Committee wishes to draw the General Assembly's attention to the recommendation of the Special Committee, which was approved by the Assembly, whereby statements made in the exercise of the right of reply should be delivered, as a general rule, at the end of the meetings (rules of procedure, annex V, para. 78). Furthermore, the General Committee recommends that delegations should exercise their right of reply at the end of the day whenever two meetings have been scheduled for that day.

#### Closing date of the session

8. At the suggestion of the Secretary-General (A/BUR/179/Rev.1, para. 7), the General Committee proposes to the General Assembly, in accordance with rule 2 of the rules of procedure, that the closing date of the twenty-seventh session should be Tuesday, 19 December 1972.

Records of the Main Committees

9. As pointed out by the Secretary-General (A/BUR/179/Rev.1, para. 8), rule 60 of the rules of procedure, as amended at the twenty-sixth session, stipulates that the First Committee shall be provided with verbatim records and that no organ of the General Assembly shall have both verbatim and summary records. As previously, the verbatim records would be the official records of the First Committee and the summary records would remain the official records of all other Main Committees. In this connexion, the General Committee recommends to the General Assembly that the option that has traditionally been approved for the Special Political Committee to obtain, on specific request, transcriptions of the debates of some of its meetings, or portions thereof, should be maintained for the twenty-seventh session. Furthermore, the General Committee wishes to draw the General Assembly's attention to paragraph 10 (e) of its resolution 2538 (XXIV) of 11 December 1969, which reads as follows:

"Speeches or statements by representatives, by the Secretary-General or his representative, or by persons presenting reports on behalf of committees or other bodies, may be reproduced in extenso in summary records or as official documents only if they serve as bases for discussion, provided that the relevant decision is taken by the body concerned after a statement of the financial implications has been submitted in accordance with regulation 13.1 of the Financial Regulations of the United Nations."

Seating arrangements

10. The General Committee took note of the seating arrangements to be observed in the plenary and in the Main Committees (A/BUR/179/Rev.1, para. 9).

Use of the General Assembly Hall by the Main Committees

11. The General Committee took note of the fact that, in addition to the General Assembly Hall, only five conference rooms (Conference Rooms 1 to 4 and the Trusteeship Council Chamber) can accommodate the membership of the Organization, making it possible to hold no more than six meetings simultaneously. At the suggestion of the Secretary-General (A/BUR/179/Rev.1, para. 10), the Committee, therefore, proposes that all the Main Committees should make full use of the General Assembly Hall when no plenary meeting is being held.

Mechanical means of voting

12. At the suggestion of the Secretary-General (A/BUR/179/Rev.1, para. 11), the General Committee proposes that the Main Committees make full use, on a rotating basis, of the mechanical means of voting available in both the General Assembly Hall and Conference Room 3.

III. ADOPTION OF THE AGENDA

13. The General Committee considered the draft agenda submitted by the Secretary-General in his memorandum (A/BUR/179/Rev.1, para. 14). This draft was based on the following documents:

- (a) Provisional agenda of the twenty-seventh session (A/8760 and Corr.2);
- (b) Supplementary list of items (A/8780);
- (c) Requests for the inclusion of additional items (A/8791 and Add.1 and Add.1/Corr.1, A/8792 and A/8793).

14. In connexion with item 12 of the draft agenda (Report of the Economic and Social Council), the General Committee noted (A/BUR/179/Rev.1, para. 13) that:

- (a) A number of reports, which the General Assembly specifically requested or which the Economic and Social Council decided to transmit to the Assembly, will be considered under this item;
- (b) The General Assembly will be called upon to consider the draft resolution entitled "Measures to improve the organization of the work of the Council", recommended by the Economic and Social Council in its resolution 1622 (LI) of 30 July 1971, and the amendments thereto (A/8578/Add.1, paras. 44-46).

15. In the course of the discussion, it was proposed that the General Committee should recommend to the General Assembly that item 21 should be deleted from the agenda and that items 52, 92, 93 and 94 should be deleted from the agenda of the twenty-seventh session and included in the provisional agenda of the twenty-eighth session. The General Committee acted on those proposals as follows:

- (a) Item 21 (Installation of mechanical means of voting)

The Committee decided to recommend that the item should be deleted from the agenda;

- (b) Item 52 (Measures to be taken against ideologies and practices based on terror or on incitement to racial discrimination or any other form of group hatred)

The Committee decided to recommend that the item should be included in the provisional agenda of the twenty-eighth session.

- (c) Item 92 (Declaration on Universal Participation in the Vienna Convention on the Law of Treaties)

The Committee decided to recommend that the item should be included in the provisional agenda of the twenty-eighth session.

- (d) Item 93 (Question of issuing special invitations to States which are not Members of the United Nations or members of any of the specialized agencies)

or of the International Atomic Energy Agency or parties to the Statute of the International Court of Justice to become parties to the Convention on Special Missions)

The Committee decided to recommend that the item should be included in the provisional agenda of the twenty-eighth session.

- (e) Item 94 (Amendment to Article 22 of the Statute of the International Court of Justice (Seat of the Court) and consequential amendments to Articles 23 and 28)

The Committee decided to recommend that the item should be included in the provisional agenda of the twenty-eighth session.

16. After a debate, in the course of which the General Committee discussed simultaneously the inclusion of items 35, 36, 37 and 96, the Committee took the following action:

- (a) Item 35 (Withdrawal of United States and all other foreign forces occupying South Korea under the flag of the United Nations) and item 36 (Dissolution of the United Nations Commission for the Unification and Rehabilitation of Korea)

The Committee decided to recommend that the items should be deleted from the agenda.

- (b) Item 37 (Question of Korea: report of the United Nations Commission for the Unification and Rehabilitation of Korea) and item 96 (Creation of favourable conditions to accelerate the independent and peaceful reunification of Korea)

By 16 votes to 7, with 1 abstention, the Committee decided to recommend that the items should be included in the provisional agenda of the twenty-eighth session.

17. The General Committee decided, by 17 votes to 4, with 3 abstentions, to recommend that item 98 (Admission of new Members to the United Nations) should be included in the agenda.

18. The General Committee decided by 15 votes to 7, with 2 abstentions, to recommend that item 99 (Measures to prevent terrorism and other forms of violence which endanger or take innocent human lives or jeopardize fundamental freedoms) should be included in the agenda.

19. Taking into account paragraphs 13 to 18 above, the General Committee recommends to the General Assembly the adoption of the following agenda: 1/

20. Taking into account the recommendations in section III above regarding the inclusion of items in the agenda, the General Committee approved the proposed allocation of items contained in paragraph 23 of the Secretary-General's memorandum (A/BUR/179/Rev.1) with the following modifications:

(b) First Committee

Item 25 (Implementation of the results of the Conference of Non-Nuclear-Weapon States and item 28 (General and complete disarmament))

The General Committee decided, on the proposal of the Secretary-General (A/BUR/179/Rev.1, para. 20), to recommend that the relevant paragraphs of the annual report of the International Atomic Energy Agency (A/8774), which is to be considered directly in plenary meeting under item 15, should be drawn to the attention of the First Committee in connexion with its consideration of items 25 and 28.

(c) Second Committee

The General Committee decided to recommend that chapter VII, section D (United Nations Children's Fund), of the report should be allocated to the Second Committee. - (vii) Chapter XIX, section A (Review of the Council's co-ordinating machinery, methods of work and procedures), might be of interest to the Fifth Committee.

(d) Third Committee

The General Committee decided to recommend, on the proposal of the Secretary-General (A/BUR/179/Rev.1, para. 18), that the General Assembly should suggest that:

21. - (d) Item 100 (Strengthening of the role of the United Nations with regard to the maintenance and consolidation of international peace and security, the development of co-operation among all nations and the promotion of the rules of international law in relations between States)

The General Committee decided to recommend that the item should be considered directly in plenary meeting.

- (e) Item 101 (Non-use of force in international relations and permanent prohibition of the use of nuclear weapons)

The General Committee decided to recommend that the item should be considered directly in plenary meeting.

23. The General Committee decided to recommend that item 98 (Admission of new Members to the United Nations) should be considered directly in plenary meeting.

24. Furthermore, the General Committee took the following action:
