

JOINT COMMUNIQUE
THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN
THE REPUBLIC OF TAJIKISTAN AND THE REPUBLIC OF PERU

The Republic of Tajikistan and the Republic of Peru, convinced that the cooperation and mutual understanding among nations are the best guarantee for international peace and security, and in accordance with international law and the principles and purposes of the United Nations Charter, have agreed to establish diplomatic relations at the non-resident Ambassadorial level.

The procedure for the establishment of relations between both countries is consistent with the 1961 Vienna Convention on Diplomatic Relations and the 1963 Vienna Convention on Consular Relations.

Done at New York, on the twenty first day of January of the year 2000, in duplicate, in Spanish and English, all texts being equally authentic.

COMUNICADO CONJUNTO
SOBRE ESTABLECIMIENTO DE RELACIONES DIPLOMATICAS ENTRE
LA REPUBLICA DE TAYIKISTAN Y LA REPUBLICA DEL PERU

La República de Tayikistán y la República del Perú, convencidos que la cooperación y el entendimiento mutuos entre las naciones son la mejor garantía para la paz y seguridad internacionales y conforme con las normas de derecho internacional y los principios y propósitos de la Carta de las Naciones Unidas, han acordado establecer relaciones diplomáticas, a nivel de embajadores no residentes.

Para el establecimiento de las relaciones entre ambos países se procede de acuerdo con la Convención de Viena de 1961 sobre Relaciones Diplomáticas y la Convención de Viena de 1963 sobre Relaciones Consulares.


