





On the basis of the principles and purposes of the Charter of the United Nations and international law, particularly on the respect for and promotion of international peace and security, equality among States, national sovereignty, independence, international treaties, territorial integrity and non-interference in the internal affairs of States,

Have decided to establish diplomatic relations at Ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date of signing of this Joint Communiqué.






## **COMMUNIQUE CONJOINT RELATIF A L'ETABLISSEMENT DES RELATIONS DIPLOMATIQUES ENTRE LA REPUBLIQUE CENTRAFRICAINE ET LA REPUBLIQUE DES FIJI**

### **La République Centrafricaine et la République des Fiji**

Désireuses de promouvoir la compréhension mutuelle et de consolider les relations amicales et de coopération entre leurs peuples ;

Se conformant aux principes et aux objectifs de la Charte des Nations Unies et aux principes du Droit international, notamment sur le respect et la promotion de la paix et la sécurité internationale, l'égalité entre les pays, la souveraineté nationale, l'indépendance, les traités internationaux, l'intégrité territoriale et la non-ingérence aux affaires intérieures des pays,
