We, therefore, kindly request Your Excellency to have the enclosed Joint Communiqué circulated to all Member States of the United Nations for their information.



**JOINT COMMUNIQUE  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN  
BRUNEI DARUSSALAM

THE GOVERNMENTS OF HIS MAJESTY THE SULTAN AND YANG DI-PERTUAN OF BRUNEI DARUSSALAM AND THE REPUBLIC OF THE CONGO, DESIROUS OF PROMOTING RELATIONS OF FRIENDSHIP AND COOPERATION IN CONFORMITY WITH THE INTEREST AND DESIRE OF THE TWO PEOPLES, HAVE DECIDED TO ESTABLISH DIPLOMATIC RELATIONS BETWEEN THE TWO COUNTRIES AT AMBASSADORIAL LEVEL AS FROM MAY 15, 2000.


THE TWO GOVERNMENTS HAVE AGREED TO DEVELOP FRIENDLY RELATIONS AND COOPERATION BETWEEN THE TWO COUNTRIES ON THE BASIS OF THE PRINCIPLES ENSHRINED IN THE CHARTER OF THE UNITED NATIONS AND THE NORMS OF THE INTERNATIONAL LAW.

SIGNED IN NEW YORK, ON MAY 15, 2000 IN TWO ORIGINALS, IN THE ENGLISH AND FRENCH LANGUAGES, BOTH TEXTS BEING EQUALLY AUTHENTIC.

Ont décidé d'établir des relations diplomatiques au niveau d'Ambassadeur à compter du 15 mai 2000.


