JOINT COMMUNIQUÉ

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS

BETWEEN

THE REPUBLIC OF LITHUANIA

AND

THE REPUBLIC OF THE GAMBIA

The Government of the Republic of Lithuania and the Government of the Republic of The Gambia, guided by mutual willingness to develop friendship and cooperation between the two States in political, trade, economic and other fields, have decided to establish diplomatic relations as of the date of the signing of this Joint Communiqué.

The two States have agreed to establish diplomatic relations based on the 1961 Vienna Convention on Diplomatic Relations, 1963 Vienna Convention on Consular Relations, principles and purposes of the United Nations Charter and principles and norms of the International Law.

The Government of the Republic of Lithuania and the Government of the Republic of The Gambia are fully convinced that the establishment of diplomatic relations corresponds to the interests of both States and will further strengthen international peace and security.

In witness whereof, the undersigned Plenipotentiaries have signed this Joint Communiqué in the English language.
