PROTOCOL

on the establishment of diplomatic relations between the Government of the Principality of Andorra and the Government of the Republic of Seychelles

The Government of the Principality of Andorra and the Government of the Republic of Seychelles,

Guided by the mutual desire to initiate and develop ties of friendship and cooperation between the two States in political, cultural, commercial, economic and other fields,

With the intention to base this relation on the principles and norms of the Charter of the United Nations and international law, particularly, equality among states, respect for independence, national sovereignty, territorial integrity, and non-interference in the internal affairs of the states,

Have decided to establish diplomatic and consular relations as of the date of the signing of this Protocol on the basis of the Vienna Convention on Diplomatic Relations of 18 April 1961, and the Vienna Convention on Consular Relations of 24 April 1963,

The Government of the Principality of Andorra and the Government of the Republic of Seychelles have also agreed that, on appropriate dates, ambassadors and consuls will be designated.
