

# ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN MONGOLIA AND THE REPUBLIC OF UGANDA

#### MONGOLIA AND THE REPUBLIC OF UGANDA,

Guided by mutual willingness to develop friendly, peaceful and cooperative relations in the diplomatic, political, economic, humanitarian and other fields,

Convinced that the establishment of diplomatic relations corresponds to the interest of both States in accordance with the principles and purposes of the United Nations Charter and the provisions of the Vienna Convention on Diplomatic Relations of 18<sup>th</sup> April 1961;

Have agreed to establish diplomatic relations, as at the date of signature of this Joint Communiqué.

In witness thereof, the undersigned representatives, duly authorized by their respective Government, have signed this Joint Communiqué, in New York on 20... th November 2013, in duplicate, each in English and Mongolian, both texts being equally authentic.
