### THE MISUSE OF DRUGS ACT, 1973. (ACT 5 of 1973)

#### THE MISUSE OF DRUGS (AMENDMENT) REGULATIONS, 1975.

In exercise of the powers conferred by section 34 of the Misuse of Drugs Act, 1973, the Minister for Health and Home Affairs hereby makes the following Regulations:

- 1. These Regulations may be cited as the Misuse of Drugs (Amendment) Regulations, 1975.
- G.N. Nos. S 234/73 S 47/74.
- 2. Regulation 18 of the Misuse of Drugs Regulations, 1973 (hereinafter in these Regulations referred to as "the principal Regulations") is hereby amended:
  - (a) by inserting immediately before the word "dealer" appearing in the second line of paragraph (1) thereof the word "wholesale";
  - (b) by inserting immediately after paragraph (1) thereof the following new paragraph:
    - "(2) A retail dealer in any drug specified in the First Schedule shall keep every invoice or other like record issued in respect of each quantity of such a drug obtained by him."; and
  - (c) by renumbering existing paragraph (2) thereof as paragraph (3).
- 3. Paragraph (2) of regulation 20 of the principal Regulations is hereby amended by deleting the words "or a" appearing in the first line thereof and substituting therefor the expression", theatre or".
  - 4. The First Schedule to the principal Regulations is hereby amended:
  - (a) by inserting immediately after paragraph 3 thereof the following new paragraph:
    - "4. Preparations of difenoxin containing, per dosage unit, not more than 0.5 mg. of difenoxin and a quantity of atropine sulphate equivalent to at least 5 per cent of the dosage of difenoxin."; and
  - (b) by renumbering existing paragraphs 4, 5 and 6 thereof as paragraphs 5, 6 and 7 respectively.
  - 5. The Second Schedule to the principal Regulations is hereby amended:
  - (a) by inserting immediately below the expression "Acetorphine." appearing in paragraph 1 thereof the expression "Acetylmethadol.";
  - (b) by inserting immediately below the expression "Cocaine." appearing in paragraph 1 thereof the expression "Codoxime.";
  - (c) by inserting immediately below the expression "Diethylthiambutene." appearing in paragraph 1 thereof the expression "Difenoxin.";
  - (d) by deleting the expression "Dihydro-codeinone O-carboxy-methyloxime." appearing in paragraph 1 thereof;
  - (e) by inserting immediately below the expression "Dipipanone." appearing in paragraph 1 thereof the expression "Drotebanol."; and
  - (f) by inserting immediately below the expression "Pholoodine." appearing in paragraph 6 thereof the expression "Propiram.".

- 6. The Fourth Schedule to the principal Regulations is hereby amended:
- (a) by inserting immediately below the expression "Psilocin." appearing in paragraph 1 thereof the expression "Psilocybine."; and
- (b) by inserting immediately below the expression "2, 5-Dimethoxy-\$\infty\$, 4-dimethyl phenethylamine." appearing in paragraph 1 thereof the expression "1-Hydroxy-3-penthyl-6a, 7, 10, 10a-tetrahydro-6, 6, 9-trimethyl-6-H-dibenzo [b,d] pyran.".
- 7. The Seventh Schedule to the principal Regulations is hereby deleted and the following substituted therefor:

#### "SEVENTH SCHEDULE.

Second Column.

(a) Licence to sell controlled drugs by wholesale ... \$50.00 per calendar year or part thereof.

(b) Licence to manufacture
controlled drugs ... \$50.00 per calendar year or
part thereof.

(c) Licence to import controlled drugs ... \$10.00

(d) Licence to export controlled drugs ... \$5.00

(e) Amendment to any licence on any single occasion ... \$5.00.".

## THE MISUSE OF DRUGS ACT, 1973 (ACT 5 of 1973)

THE MISUSE OF DRUGS (AMENDMENT) REGULATIONS, 1976.

In exercise of the powers conferred by section 34 of the Misuse of Drugs Act, 1973, the Minister for Home Affairs hereby makes the following Regulations:

- These Regulations may be cited as the Misuse of Drugs (Amendment)
   Regulations, 1976, and shall come into operation on the 17th day of September,
   1976.
- 2. The First Schedule to the Misuse of Drugs Regulations, 1973, is hereby amended:

- (a) by inserting immediately after paragraph 5 thereof the following paragraph:
- s 60/75.
- "6. Any preparation of propiram containing, per dosage unit, not more than 100 milligrammes of propiram calculated as base and compounded with at least the same amount of methylcellulose in weight.";

- (b) by renumbering paragraphs 6 and 7 thereof as paragraphs 7 and 8 respectively; and
- (c) by deleting the figure "5" appearing in the second line of paragraph 8 thereof and substituting therefor the figure "7".
