With the purpose to promote mutual understanding and strengthen the friendship and cooperation among their two peoples,

On the basis of the principles and purposes of the Charter of the United Nations and international law, particularly on the respect for and promotion of international peace and security and on the respect of international treaties, equality among States, national sovereignty, independence, territorial integrity and non-interference in the internal affairs of States,

Have decided to establish diplomatic relations at ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date of the signing of this Joint Communiqué.

In witness thereof, the undersigned representatives, duly authorised by their respective Governments, have signed this Joint Communiqué in duplicate in Latvian and English languages, both texts being equally authentic.
