JOINT COMMUNIQUE ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF FIJI AND THE KYRGYZ REPUBLIC

The Republic of Fiji and the Kyrgyz Republic, guided by a shared willingness to develop and strengthen the ties of friendship and cooperation between the two countries, have decided to establish diplomatic relations at the level of Ambassadors in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date of the signing of this Joint Communique.

Both parties wish to manifest their confidence that the establishment of diplomatic relations and the exchange of Ambassadors between both countries will contribute to the development of bilateral cooperation and the consolidation of world peace.

The Republic of Fiji and the Kyrgyz Republic affirm their will to build their bilateral relationship in accordance with the Charter of the United Nations and on the basis of the principles of peaceful coexistence, equality and mutual respect of sovereignty of each other's territory, and the non-interference in each other's internal affairs.

Done in New York, on 14 February 2014 in duplicate originals in the English, Kyrgyz and Russian languages, all of which being equally authentic.
