# JOINT COMMUNIQUÉ ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS

## BETWEEN THE REPUBLIC OF UGANDA AND THE REPUBLIC OFARMENIA

The Republic of Uganda and the Republic of Armenia;

Desirous to promote mutual understanding and strengthen friendship and cooperation between the two countries;

Guided by the principles and purposes of the United Nations Charter and international law;

Have decided to establish diplomatic relations with effect from the date of the signature of this Joint Communiqué under the terms of the Vienna Convention on Diplomatic Relations of 18 April 1961 and the Vienna Convention on Consular Relations of 24 April 1963;

In witness whereof, the undersigned, being duly authorized by their respective Governments, have signed the Joint Communiqué in two original copies in English and Armenian languages, all texts being equally authentic.
