

JOINT COMMUNIQUE

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE GOVERNMENT OF THE KINGDOM OF SAUDI ARABIA AND THE GOVERNMENT OF SAINT KITTS AND NEVIS

The Government of the Kingdom of Saudi Arabia and the Government of Saint Kitts and Nevis,

Guided by their mutual willingness to develop and strengthen friendship and cooperation between the two States in political, economic, social and humanitarian and other fields, in accordance with the principles and norms enshrined in the Charter of the United Nations, International law and the Vienna convention on diplomatic Relations of 18 April 1961; and desirous of furthering international security through peaceful coexistence,

Have decided to establish diplomatic relations through the signing of a Joint Communiqué.

In witness thereof, the undersigned Representatives, authorized by their respective Governments, have duly signed this Joint Communiqué.



**PROTOCOL
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN
THE GOVERNMENT OF THE KINGDOM OF SAUDI ARABIA
AND THE GOVERNMENT OF SAINT KITTS AND NEVIS**

The Kingdom of Saudi Arabia and the Government of Saint Kitts and Nevis,

Guided by their mutual willingness to strengthen relations and broaden cooperation between the two Countries; and in support of international security and peace, have decided to establish diplomatic relations, in accordance with the Provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961.

Both parties are confident that this step will lead to an enhanced and fruitful cooperation between the two countries in political, economic, technical, commercial, and cultural fields; and that this step will constitute a manifestation of the aspirations of both countries to establish the best friendly relations in various fields.


This protocol was drafted in New York on the 29th day of the Month of September of 2016 AD, corresponding to the 28th day of the Month of September 2016 Dhul-Hijjah of the year 1437 AH; and signed in duplicate in Arabic and English, all texts being equally authentic.

بروتوكول إقامة علاقات دبلوماسية

بيان

المملكة العربية السعودية واتحاد سانت كيتس ونيفيس

إن المملكة العربية السعودية واتحاد سانت كيتس ونيفيس، حرصاً منها على تعزيز العلاقات بين البلدين، وتوسيع آفاق التعاون بينهما، ودعمها لقضايا الأمن والسلام في العالم، ورغبة في توطيد أواصر التعاون المثمر بين البلدين في المجالات السياسية والاقتصادية والفنية والتجارية والثقافية، وتحسينها لتطورات البلدين نحو إقامة أفضل العلاقات والصلات الودية بينهما في مختلف الميادين، قررتا إقامة علاقات دبلوماسية بين البلدين، بناءً على أحكام اتفاقية العلاقات والخصائص الدبلوماسية الموقعة في فيينا في اليوم الثامن من شهر أبريل لعام ١٩٦١ م.

حرر هذا البروتوكول في نيويورك اليوم ٢٨ من شهر ذو الحجة للعام ١٤٣٧ من الميلاد الموافق للـ ٢٩ من شهر سبتمبر للعام ٢٠١٦ م ميلادي ووقع على ثلاث نسخ بكل من اللغات العربية والإنجليزية والإسبانية، وتنصان متساويان في الحجية.
