Addendum

1. At its 2023rd plenary meeting, on 17 December 1971, the General Assembly approved the calendar of conferences and meetings of the United Nations for 1972 contained in annex I of the Secretary-General's report (A/8448 and Add.1), in which it was indicated (A/8448/Add.1, para. 3) that an addendum would be issued to reflect any modifications required by subsequent decisions of the General Assembly.
2. The present addendum reflects those modifications only in terms of those organs that have been extended and new organs established by the General Assembly during its twenty-sixth session. Other modifications regarding changes of dates and locations will be communicated to delegations early in January.
