**On the Establishment of Diplomatic Relations**

**The Republic of the Sudan**  
**And**  
**The Republic of Fiji**

*The Republic of the Sudan and the Republic of Fiji, being desirous of strengthening the friendly relations existing between the two countries and promoting mutually beneficial co-operation and on the basis of mutual respect and the principles of sovereignty, territorial integrity and non-interference in the internal affairs of the states.*

*Guided by the principles and purposes of the Charter of the United Nations and the Vienna Convention on Diplomatic Relations of 18 April, 1961.*

*Have decided to establish diplomatic relations at Ambassadorial level with effect from the date of signature of the present Joint Communiqué.*

*In witness thereof, the undersigned plenipotentiaries, duly authorized by their Governments, have signed the Joint Communiqué.*
