

**JOINT COMMUNIQUÉ  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN GEORGIA AND THE DOMINICAN REPUBLIC**

Georgia and the Dominican Republic, guided by a shared willingness to develop and strengthen the ties of friendship and cooperation between the two countries, have decided to establish diplomatic relations at the level of Ambassadors.

Both parties wish to manifest their confidence in that the establishment of diplomatic relationship and the exchange of Ambassadors in between both countries will contribute to the development of the bilateral cooperation and the consolidation of world peace.

Georgia and the Dominican Republic reaffirm their will to build their bilateral relationship in accordance with the Charter of the United Nations and in the basis of the principles of peaceful coexistence, equally and mutual respect of sovereignty of each others territory and the non interference in each others internal affairs.

Done and signed in New York, on the 22<sup>nd</sup> of January 2010, in two originals in Georgian, Spanish and English, with the same tone and equally authentic.


