We have the honour to inform you that diplomatic relations were established between the People's Democratic Republic of Algeria and the Republic of Fiji today, 2 June 2010.

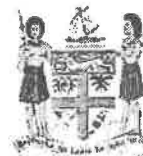

**JOINT COMMUNIQUE
FOR THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN
THE PEOPLE'S DEMOCRATIC REPUBLIC OF ALGERIA
AND
THE REPUBLIC OF FIJI**

The Government of the People's Democratic Republic of Algeria and the Government of the Republic of Fiji;

Desirous of developing and strengthening relations of friendship and cooperation between the two countries;

Have agreed to establish diplomatic relations between the two states, at the Ambassadorial level, with effect from the date of signature of this Joint Communiqué, in accordance with the principles and purposes of the United Nations Charter and the Vienna Convention on Diplomatic Relations of 18 April 1961.

Done in New York, on 2 June 2010, in two original texts, in the English and Arabic languages, both texts being equally authentic.
