The Republic of Maldives and the Republic of Nicaragua, guided by a shared willingness to develop and strengthen the ties of friendship and cooperation between the two countries, have decided to establish diplomatic relations at the level of non-resident Ambassadors.

Both parties wish to manifest their confidence in that the establishment of diplomatic relations and the exchange of Ambassadors in between both countries will contribute to the development of bilateral cooperation and the consolidation of world peace.

The Republic of Maldives and the Republic of Nicaragua reaffirm their will to build their bilateral relationship in accordance with the Charter of the United Nations and the International Law, including the principles of peaceful coexistence, equality and mutual respect for the sovereignty of each others territory, and the non interference in each others internal affairs.

COMUNICADO CONJUNTO
SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMATICAS ENTRE
LA REPUBLICA DE MALDIVAS Y LA REPUBLICA DE NICARAGUA

El Gobierno de la República de Maldivas y el Gobierno de la República de Nicaragua, guiados por su disposición de promover y fortalecer de las relaciones de amistad y cooperación entre los dos países, han decidido establecer relaciones diplomáticas a nivel de Embajadores no residentes.

Ambas partes desean manifestar su confianza en que el establecimiento de relaciones diplomáticas y el intercambio de Embajadores entre los dos países contribuirán al desarrollo de la cooperación bilateral y la consolidación de la paz mundial.
