The Government of Bosnia and Herzegovina and the Government of the Republic of Fiji:

Guided by their mutual willingness to develop and strengthen friendship and cooperation between the two States in political, economic, social, humanitarian and other fields in accordance with the principles and norms enshrined in the Charter of the United Nations;

Have decided to establish diplomatic relations at the Ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18th April 1961, as of the date of the signing of this Joint Communiqué;

The Government of Bosnia and Herzegovina and the Government of the Republic of Fiji express their mutual confidence that the establishment of diplomatic relations corresponds to the national interests of both States and that it will help consolidate international peace and security, as well as peaceful co-existence.

In witness thereof, the undersigned Representatives, duly authorized by their respective Governments, have signed this Joint Communiqué in English and languages of Bosnia and Herzegovina (Bosnian, Serbian and Croatian), being all texts equally authentic. In case of divergence in interpretation of the Joint Communiqué, the English text will prevail.
