**JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC
BETWEEN GEORGIA AND THE REPUBLIC OF PARAGUAY**

Georgia and the Republic of Paraguay;

Desirous to promote mutual understanding and strengthen friendship and cooperation between the two countries,

Guided by the principles and purposes of the United Nations Charter and international law, particularly the respect and promotion of international peace and security, equality among States, due respect for national sovereignty and territorial integrity, independence and international treaties, and non-interference in internal affairs of State.

Have decided to establish diplomatic relations at Ambassadors level under the terms of Vienna Convention on Diplomatic Relations of 18 April 1961, from the date of the signature of this Joint Communiqué.

In witness whereof, the undersigned, being duly authorized by their respective Governments, have signed the Joint Communiqué in three original copies in Georgian, Spanish and English languages, being all texts equally authentic.

**COMUNICADO CONJUNTO
SOBRE EL ESTABLECIMIENTO DE RELACIONES DIPLOMATICAS
ENTRE
LA REPUBLICA DEL PARAGUAY Y GEORGIA**

La República del Paraguay y Georgia;

Deseosas de promover el entendimiento mutuo y de estrechar la amistad y cooperación entre ambos pueblos.

Guiados por los principios y propósitos de la Carta de las Naciones Unidas y del Derecho Internacional, particularmente el respeto y la promoción de la paz y seguridad internacionales, la igualdad entre los Estados, la soberanía nacional, la independencia, y los tratados internacionales, así como la integridad territorial y la no interferencia en los asuntos internos de los Estados;

Han decidido establecer relaciones diplomáticas, a nivel de Embajadores no residentes, bajo los términos de la Convención de Viena sobre Relaciones Diplomáticas del 18 de abril de 1961, a partir de la firma del presente Comunicado Conjunto.

En fe de lo cual, los abajo firmantes, debidamente autorizados por sus respectivos Gobiernos, firman el Presente Comunicado Conjunto en tres ejemplares originales, en los idiomas español, georgiano e inglés, siendo todos los textos igualmente auténticos.
