## JOINT COMMUNIQUE on the establishment of diplomatic relations between the Republic of Azerbaijan and Saint Lucia

The Government of the Republic of Azerbaijan and the Government of Saint Lucia,

Desirous to promote mutual understanding and strengthen the friendship and cooperation among their two Peoples, guided by the Charter of the United Nations and the principles of the international law, particularly on international peace and security, equal sovereignty, territorial integrity, inviolability of borders, non-interference in the internal affairs,

Have decided to establish the diplomatic relations in accordance with the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961, as of the date of the signing of this Joint Communiqué,

Done in New York on 11 March 2010, each one in Azerbaijani and English languages. All texts being equally authentic.
