Please accept, Excellency, the assurances of our highest consideration.



**JOINT COMMUNIQUÉ
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS
BETWEEN THE REPUBLIC OF LIBERIA AND GEORGIA**

The Republic of Liberia and Georgia, guided by mutual willingness to develop relations of friendship and cooperation between the two countries in political, economic, cultural and other fields, have decided to establish diplomatic relations at the Ambassadorial level.

The Parties are convinced that the establishment of diplomatic relations between the Republic of Liberia and Georgia corresponds to the interests of the two states, and will help to consolidate international peace and security, as well as peaceful co-existence.

The Parties, guided by the Vienna Convention on Diplomatic Relations, of April 18th, 1961 and the principles enshrined in the Charter of the United Nations and other fundamental norms and principles of international law, have agreed to develop the relations between the two States on the basis of the principles of sovereign equality, and respect of territorial integrity.

In Witness thereof, the undersigned Representatives, duly authorized by their respective Governments have signed the Joint Communiqué in English and Georgian languages, all texts being equally authentic. In case of divergence in interpretation of the Joint Communiqué, English text will prevail.


