JOINT COMMUNIQUE

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF SURINAME AND THE GRAND-DUCHY OF LUXEMBOURG

The Republic of Suriname and the Grand-Duchy of Luxembourg,

Being desirous of strengthening the friendly relations existing between the two countries and peoples and of promoting mutually beneficial co-operation on the basis of the principles of peaceful coexistence, equality and mutual respect for national sovereignty, territorial integrity and non-interference in the internal affairs of States,

Guided by the principles and objectives enshrined in the Charter of the United Nations and International Law,

Have decided to establish diplomatic relations in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, with effect from the date of signature of the present Joint Communiqué.

Done in New York, on February 1st, 2010, in duplicate in Dutch, English and French, all texts being equally authentic.

La République du Suriname et le Grand-Duché de Luxembourg,


