## Letter dated 10 November 2017 from the Permanent Representative of Azerbaijan to the United Nations addressed to the Secretary-General

Upon the instructions from my Government, I have the honour to convey herewith the record of violations of the ceasefire by the Republic of Armenia in October 2017 (see annex).\* During the reporting period, Armenia violated the ceasefire regime 1,654 times and continued the use of large-calibre guns and heavy weaponry from its positions in the occupied territories of the Republic of Azerbaijan and from its own territory.

As a result, five servicemen of the armed forces of the Republic of Azerbaijan were wounded during one month.

The continuous occupation of a large part of the territory of the Republic of Azerbaijan by the armed forces of Armenia remains the main obstacle in the settlement of the conflict and the only source of the escalation of the situation on the frontline and the occurrence of hostilities and casualties.

The sooner the Republic of Armenia withdraws its troops from the occupied territories of the Republic of Azerbaijan, the sooner peace and stability can be restored in the region.

I should be grateful if you would have the present letter and its annex circulated as a document of the General Assembly, under agenda items 35 and 40, and of the Security Council.
