International assistance for the economic rehabilitation of Angola

The General Assembly,

<u>Recalling</u> its resolution 45/233 of 17 September 1990 regarding international assistance for the economic rehabilitation of Angola,

Recalling Security Council resolutions 387 (1976) of 31 March 1976, 475 (1980) of 27 June 1980, 628 (1989) of 16 January 1989 and other resolutions of the Council regarding international assistance for the economic rehabilitation of Angola, in which, <u>inter alia</u>, the international community was requested to render assistance to Angola,

Deeply concerned about the serious economic situation in Angola,

<u>Concerned</u> that the drought which ravaged the central and south portions of the country has taken thousands of human lives and caused great suffering, which is still being felt, A/C.2/46/L.49 English Page 2

<u>Taking into consideration</u> the determined efforts that have been made by all parties concerned, which, with the signing of the Peace Accords for Angola, pave the way for economic and social rehabilitation of Angola,

<u>Conscious</u> of the need for greater engagement on the part of the international community in rendering assistance for the economic rehabilitation of Angola,

1. Takes note of the report of the Secretary-General concerning international assistance for the economic rehabilitation of Angola 1/ and welcomes with appreciation the support given up until now;

2. <u>Welcomes</u> the signing of the Peace Accords for Angola which have created political conditions for the economic and social rehabilitation of Angola;

3. <u>Expresses its appreciation</u> to the international community for the emergency humanitarian assistance rendered to Angola through the Special Relief Programme for Angola, and appeals for generous contributions for the continuation of the Programme in 1992;

4. <u>Reiterates</u> its appeal to the international community to continue to render material, technical and financial assistance necessary to the economic rehabi itation of Angola;

5. <u>Requests</u> the Secretary-General, in cooperation with the international community, to continue to mobilize organizations and organs of the United Nations system in order to increase the level of economic assistance for Angola;

6. <u>Also requests</u> the Secretary-General to report to the General Assembly at its forty-seventh session on the implementation of the present resolution;

7. Decides to include in the provisional agenda of its forty-seventh session the item entitled "International assistance for the economic rehabilitation of Angola".
