The General Assembly,

<u>Becalling</u> Security Council resolutions 605 (1987) of 22 December 1987, 607 (19°8) of 5 January 1988, 608 (1988) of 14 January 1988, 636 (1989) of 6 July 1989, 641 (1989) of 30 August 1989, 672 (1990) of 12 October 1990, 673 (1990) of 24 October 1990, 681 (1990) of 20 December 1990 and 694 (1991) of 24 May 1991,

Taking note of the relevant reports of the Secretary-General, 1/

<u>Alarmed</u> by the continuing deportation of Palestinians from the occupied Palestinian territory by the Israeli authorities,

Recalling the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, 2/ in particular article 1 and the first paragraph of article 49, which read as follows:

"Article 1

"The High Contracting Parties undertake to respect and to ensure respect for the present Convention in all circumstances."

"Article 49

"Individual or mass forcible transfers, as well as deportations of protected persons from occupied territory to the territory of the occupying Power or to that of any other country, occupied or not, are prohibited, regardless of their motive ...",

Reaffirming the applicability of the Fourth Geneva Convention to the occupied Palestinian territory, including Jerusalem, and other Arab territories occupied by Israel since 1967,

- 1. Strongly deplores the continuing disregard by Israel, the occupying Power, of the relevant resolutions and decisions of the Security Council and resolutions of the General Assembly;
- 2. <u>Demands</u> that the Government of Israel, the occupying Fower, rescind the illegal measures taken by its authorities in deporting Palestinians and that it facilitate their immediate return;
- 3. <u>Calls upon</u> Israel, the occupying Power, to cease forthwith the deportation of Palestinians and to abide scrupulously by the provisions of the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949;
- 4. Requests the Secretary-General to report to the General Assembly as soon as possible but not later than the beginning of its forty-seventh session on the implementation of the present resolution.
