ON THE

ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF GUYANA AND THE

REPUBLIC OF THE GAMBIA

The Government of the Republic of Guyana and the Government of the Republic of the

Gambia,

Desirous of promoting relations of friendship and cooperation in conformity with the

interests and desires of their peoples,

Aspiring to develop their relations on the basis of equality, mutual respect, self-

determination, independence, respect for sovereignty and territorial integrity and non-

interference in the internal affairs of each other in accordance with the principles and

objectives enshrined in the Charter of the United Nations and the norms of international law,

Have decided to establish diplomatic relations as of the date of the signing of this Joint

Communiqué in accordance with the provisions of the Vienna Convention on Diplomatic

Relations of April 18, 1961.
