## Land violations committed in September 2017

Date	Time	Nature of violation
1 September	0800	Inside the occupied Shab'a Farms, in the area west of the Radar position, the Israeli enemy continued work on a dirt road that it had begun building on 8 August 2017. The enemy used two trench-diggers and a bulldozer, which were escorted by an enemy patrol comprising 25 soldiers and two Merkava tanks. At 1800 hours, the Israeli enemy finished its work.
4 September	2000	Inside the occupied Shab'a Farms, the Israeli enemy fired three flares over the Radar position.
5 September	1000	Inside the occupied Shab'a Farms, near the Radar position, the Israeli enemy continued work on a dirt road that it had begun building on 8 August 2017. The enemy used two trench-diggers and a bulldozer, which were escorted by an enemy patrol comprising 25 soldiers and two Merkava tanks. At 1630 hours, the Israeli enemy finished its work. The soldiers left in the direction of occupied territory, while the vehicles remained on site.
6 September	1000	Inside the occupied Shab'a Farms, near the Radar position, the Israeli enemy continued work on a dirt road that it had begun building on 8 August 2017. The enemy used two trench-diggers and two trucks to transport the soil. The construction vehicles were escorted by an enemy patrol comprising approximately 30 soldiers. Two Merkava tanks positioned themselves near the site. At 1730 hours, the Israeli enemy finished its work.
	1200	Inside the occupied Shab'a Farms, between Jabal al-Summaqah and Ruwaysat al-Alam, several explosions were heard.
	1800	Inside the occupied Shab'a Farms, several bursts of medium-weapons fire were heard.
7 September	0900	Inside the occupied Shab'a Farms, near the Radar position, the Israeli enemy continued work on a dirt road that it had begun building on 8 August 2017. The enemy used two trench-diggers and two trucks to transport the soil. The construction vehicles were escorted by an enemy patrol comprising approximately 25 soldiers. Two Merkava tanks positioned themselves near the site. At 1615 hours, the Israeli enemy finished its work.
8 September	1850 1905	Vehicles were observed moving about and smoke was seen rising from the Israeli enemy's Ruwaysat al-Alam position inside the occupied Shab'a Farms.
9 September	1500	East of the town of Kafr Shuba, opposite the Israeli enemy Ruwaysat al-Alam position, a Lebanese army patrol found a suspicious object that seemed to be an Israeli enemy sensor system. The device was connected to two explosive devices which were in turn connected to two anti-personnel mines, which resembled Israeli-made Claymore mines, inside a fibreglass

		casing camouflaged to look like a rock. It had been planted at the site by the Israeli enemy at an earlier time in order to monitor Lebanese territory. At 1800 hours, a patrol belonging to the Indian contingent of the United Nations Interim Force in Lebanon (UNIFIL) approached and reconnoitred the site.
10 September	0800	Inside the occupied Shab'a Farms, near the Radar position, the Israeli enemy continued work on a dirt road that it had begun building on 8 August 2017. The enemy used a trench-digger and a truck to transport the soil. The construction vehicles were escorted by an enemy patrol comprising approximately 25 soldiers who took up positions in the surrounding area. At 1745 hours, the Israeli enemy finished its work.
	0830 0915	Inside the occupied Shab'a Farms, in the area around the Radar position, several bursts of light and medium automatic weapons fire were heard.
	1600 1815	An Israeli enemy bulldozer was seen clearing the brush around its position west of Ghajar.
11 September	0830	Inside the occupied Shab'a Farms, near the Radar position, the Israeli enemy continued work on a dirt road that it had begun building on 8 August 2017. The enemy used two trench-diggers, a crane and a truck. The construction vehicles were escorted by an enemy patrol which took up position in the surrounding area. At 1700 hours, the Israeli enemy finished its work.
	1040 1140	Inside occupied Palestinian territory, opposite the town of Kafr Killa, at point B83, approximately 25 civilians (men, women and children) approached the site and took photographs of Lebanese territory. They then left in the direction of occupied territory.
12 September	0800	Inside the occupied Shab'a Farms, in the area west of the Radar position, the Israeli enemy continued the excavation, building of fortifications and erection of earthen berms that had started on 8 August 2017. The enemy used two trench-diggers and a truck. The construction vehicles were escorted by an Israeli enemy patrol comprising approximately 25 soldiers, who deployed in the surrounding area, as well as two Merkava tanks and two Hummer vehicles. At 1635 hours, the Israeli enemy finished its work and headed in the direction of occupied territory.
13 September	0900	Inside occupied Palestinian territory, near the Israeli enemy position at Jall al-Dayr south of Aytarun, opposite the town of Aytarun, two trench- diggers, a D9 excavator, a Defender vehicle and five Israeli enemy soldiers breached the technical fence. They continued digging a dirt road and clearing brush between the technical fence and the Blue Line, without breaching it. They strung camouflage netting between the trees in order to establish an observation point near the technical fence opposite point B52(3). They were escorted from inside occupied territory by a Defender vehicle, a white civilian pickup truck and a Merkava tank, which trained its cannon on a Lebanese Army patrol. At 1715 hours, the Israeli enemy finished its work and the vehicles left in the direction of occupied territory.

13 September	0915	Inside the occupied Shab'a Farms, in the area west of the Radar position, the Israeli enemy continued the excavation, building of fortifications and erection of earthen berms which had started on 8 August 2017. The enemy used a trench-digger and a truck, which were escorted by a Merkava tank, two Hummer vehicles and an Israeli enemy patrol comprising approximately 20 soldiers, who deployed in the surrounding area. At 1600 hours, the Israeli enemy finished its work and headed in the direction of occupied territory.
14 September	0830	Inside the occupied Shab'a Farms, in the area to the west of the Radar position, the Israeli enemy continued the excavation, building of fortifications and erection of earthen berms which had started on 8 August 2017. The enemy used a trench-digger and a truck. The construction vehicles were escorted by an Israeli enemy patrol comprising approximately 20 soldiers who deployed in the surrounding area, as well as a Merkava tank and two Hummer vehicles. At 1600 hours, the Israeli enemy finished its work.
17 September	0800	Inside the occupied Shab'a Farms, in the area west of the Radar position, the Israeli enemy continued the excavation, building of fortifications and erection of earthen berms which had started on 8 August 2017. The enemy used two trench-diggers and two trucks. The construction vehicles were escorted by an Israeli enemy patrol comprising a Merkava tank, two Hummer vehicles and approximately 20 soldiers who deployed in the surrounding area. At 1800 hours, the Israeli enemy finished its work.
18 September	0830	Inside the occupied Shab'a Farms, in the area west of the Radar position, the Israeli enemy continued the excavation, building of fortifications and erection of earthen berms which had started on 8 August 2017. The enemy used three trench-diggers and two trucks. The construction vehicles were escorted by an Israeli enemy patrol comprising a Merkava tank, two Hummer vehicles and approximately 25 soldiers who deployed in the surrounding area. At 1700 hours, the Israeli enemy finished its work.
19 September	0845	Inside the occupied Shab'a Farms, in the area around the Radar position, the Israeli enemy continued excavation and fortification work that it had begun on 8 August 2017. The enemy used three trench-diggers, a bulldozer and a truck. The construction vehicles were escorted by an enemy patrol comprising a Merkava tank. At 1700 hours, the Israeli enemy finished its work.
20 September	1030	Inside the occupied Shab'a Farms, in the area west of the Radar position, the Israeli enemy continued the excavation, building of fortifications and erection of earthen berms which had started on 8 August 2017. The enemy used three trench-diggers and a truck. The construction vehicles were escorted by a Merkava tank, two Hummer vehicles and 25 soldiers who deployed in the surrounding area. At 1730 hours, the Israeli enemy finished its work, while the vehicles remained on site.
21 September	1600	An Israeli enemy patrol comprising a Hummer vehicle equipped with a surveillance camera, which was aimed at Lebanese territory, approached the area near Jabal al-Tayyarah opposite the town of Kafr Killa, inside occupied Palestinian territory.

25 September	0900	Inside the occupied Shab'a Farms, in the area west of the Radar position, the Israeli enemy continued the excavation and fortification work that it had begun on 8 August 2017. The enemy used three trench-diggers and a truck to transport the soil. The construction vehicles were escorted by an enemy patrol that deployed in the surrounding area. At 1700 hours, the Israeli enemy finished its work, while the vehicles remained on site.
	1448	Opposite the town of Yarun, a soldier from an Israeli enemy patrol raised his weapon and shouted at Lebanese civilians who were in Lebanese territory.
26 September	0830	Inside the occupied Shab'a Farms, in the area west of the Radar position, the Israeli enemy continued the excavation and fortification work that it had begun on 8 August 2017. The enemy used three trench-diggers and two trucks to transport the soil. The construction vehicles were escorted by an enemy patrol that deployed in the surrounding area. A crane (winch) was also used to take apart the steel anti-missile defences in the area from the Lebanese side. At 1800 hours, the Israeli enemy finished its work, while the vehicles remained on site.
	2200	Several explosions were heard from inside the occupied Shab'a Farms.
27 September	0800 1730	Inside the occupied Shab'a Farms, in the area west of the Radar position, the Israeli enemy continued the excavation and fortification work that it had begun on 8 August 2017. The enemy used three trench-diggers, a truck to transport the soil and a crane (winch) to repair the fence and metal defences near the site. The vehicles were escorted by two Merkava tanks and an enemy patrol comprising approximately 20 soldiers, who deployed in the surrounding area.
28 September	0830	Inside the occupied Shab'a Farms, in the area west of the Radar position, the Israeli enemy continued the excavation and fortification work that it had begun on 8 August 2017. The enemy used three trench-diggers and a truck to transport the soil. Enemy personnel, escorted by an enemy patrol that deployed in the surrounding area, erected earthen berms near the site. At 1700 hours, the Israeli enemy finished its work, while the vehicles remained on site.
	1745	From inside occupied Palestinian territory, opposite the town of Blida and the Lebanese Army post of Shu'ayb, an Israeli enemy patrol approached in a Defender vehicle. Two soldiers disembarked and directed insults and offensive expressions in Hebrew at Lebanese soldiers. At 1755 hours, the enemy patrol left in the direction of occupied territory.
29 September	_	During the tripartite meeting between a delegation from the Lebanese Army and a delegation from the enemy Israeli Army hosted by UNIFIL at its 32A-1 position at Ra's al-Naqurah, the Israeli enemy delegation deliberately provoked the Lebanese side: its soldiers entered the position bearing arms, clad in military garb and with an armed escort, while a team of snipers aimed their weapons at Lebanese territory.
