
Excellency,

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS

desirous of strengthening the existing friendly relations between their Governments and peoples, and promoting and intensifying their co-operation, in the political, economic, social and cultural fields in accordance with the principles of international co-operation as reflected in the United Nations Charter,

have decided to establish diplomatic relations on the basis of the Vienna Convention on Diplomatic Relations of 18 April 1961 at the ambassadorial level, also non-resident.

This Agreement shall come into force upon the date of the last notification by both States of the completion of their internal procedures necessary for its entry into force.


Done in New York, on 30th March, 2009, in duplicate, in the English, Italian and Portuguese languages, all texts being equally authentic.
