**JOINT COMMUNIQUÉ  
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN THE REPUBLIC OF POLAND AND THE FEDERATION OF  
SAINT KITTS AND NEVIS**

The Republic of Poland and the Federation of Saint Kitts and Nevis

*Desirous* of strengthening the friendly relations existing between the two countries,

*Interested in* developing relations between the two countries on the basis of mutual respect for the principles of sovereignty, territorial integrity and non-interference in the internal affairs of another State.

*Desirous also* of developing bilateral cooperation in different fields of interest to both countries.


*Confirming* their commitment to the objectives and principles of the United Nations in consolidating international peace and security.

*Have agreed to* establish diplomatic relations at ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of April 18, 1961, as of the date of the signing of this Communiqué.

In witness thereof, the undersigned representatives, duly authorized by their respective Governments, have signed this joint communiqué in two identical originals.
