## **JOINT COMMUNIQUE**

### **On the establishment of diplomatic relations between the Republic of Djibouti and Bosnia and Herzegovina**

#### **The Republic of Djibouti and Bosnia and Herzegovina**

Desiring to promote mutual understanding and consolidate relations of friendship and cooperation between their peoples being guided by the principles and objectives of the Charter of the United Nations;

Have decided to establish diplomatic relations as of the date of signature of the present joint communiqué;

Agree on that their diplomatic and consular relations shall be based on the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961 and the Vienna Convention on Consular Relations of 24 April 1963;

In witness whereof, their Excellencies the Permanent Representatives, being duly authorized by their respective Governments, have signed the present joint communiqué in French, English and official languages of Bosnia and Herzegovina (Bosnian, Serbian and Croatian) texts being equally authentic.


Ont décidé d'établir des relations diplomatiques à compter de la date de signature du présent communiqué commun;
