The role of Working Women Association in the Promotion of Working Women's Rights in Sudan

- Working Women Association (WWA) is a voluntary, non-governmental organization was established in 1991, and its membership includes women working in the state in the public and private sectors as well as the unorganized sector. Working Women Association look after working woman in order to serve women's issues in general and working women in particular.
- Working Women Association aims to promote the professional, intellectual and cultural competence for its membership, WWA also play a role in social integrated projects which adopt social solidarity. The Working Women Association works through multiple activities and programs to enhance the quality of economic and social status of working women through the adoption of an economic vision and initiatives designed to increase production and establish the concept of saving and rationalization of consumption.
- The issue of training and capacity building of working women in the workplace considered as a top priority for the Working Women Association in its endeavors towards improving women's sector, and to highlight her distinguished role in the labor market.
- Working Women Association calls for the achievement of social change in the circles of the Sudanese community through combat of harmful traditional habits to the health of mothers and daughters as well as the disseminations of good spiritual humanity values , virtuous practices and patterns of behavior between memberships in other areas.
- The effort exerted by the Working Women Association aimed to achieve comprehensive and sustainable development, in this context WWA since its establishment work to address the major challenges faced by women working in the various work sites in Sudan in accordance with a strategic plan and clear vision adopted as part of its action plan.
- Working Women Association works to implement the programs and activities across many axes of work i.e. economic axis, culture and training axis, media and public relations axis, social axis, legislation and human rights axis.
- Working Women Association endeavors to promote human rights in general and the rights of women in particular among working women, Working Women Association work genuinely through its branches in other locations to secure the necessary protection for women in the workplace, while ensuring they are not exposed to any form of violence or harassment due to gender, Working Women Association guided by directives enshrined in the International conventions and treaties within the framework of the International Bill of human Rights and the International Labor Organization as well as good values in the divine laws and norms which have been inherited by the people of Sudan.
- Working Women Association works in particular in the field of advocacy for the review of labor laws prevailing in Sudan in line with the conditions of working women. Working Women Association seeks to contribute to solving the problems faced by working women in the workplace by inviting various relevant agencies and partners to create an enabling working condition in order to ensure the achievement of conducive and decent environment for Sudanese women in the labor market in the various positions and at various levels.
- Working Women Association pay special attention for the promotion and advancement of the role of women in conflict resolution and peace building as the fact that women considered usually from the most affected groups by the armed conflict in the Sudan, and in this regard displaced women received considerable share estimated from WWA programs and activities in pursuit of eradicate the negative impact of the armed conflict on women , more over to provide protection and ensure rights of women in the potential areas of tension and conflicts in Sudan.
- Since the issues of women in rural areas is a major challenge for women in the Sudan, Working Women Association is sparing no effort to take care of rural working women through assistance in securing the tools of production and dissemination of models of small scale industries and secure means of microfinance to serve the development of rural women in different parts of Sudan, and contributes Besides the achievement of overall social and economic development.
- Working Women Association enjoying an observer member status at the Economic and Social Council of the United Nations (UN ECOSOC). Since the acquisition of the membership of the UN ECOSOC membership at the

year 2010 Working Women Association did not spare effort to strengthen links and to achieve communication with the United Nations specialized agencies and the counterpart organizations at the regional and international level through international partnerships and exchange of experiences and build good models in order to serve the goals and objectives set forth in the literature of the United Nations and the Economic and Social Council of the United Nations that calls for the achievement of the Millennium Development Goals , empowerment of women and enhancement of women capabilities and improvement of women situation. In this context Working Women Association is willing to express its readiness to collaborate with the regional and International organizations, brotherly countries and UN agencies working in the field of women's development in order to serve the noble objectives of the development of Sudanese women and empowering them in various fields.

- Women working in Sudan continue to struggle to prove themselves in the various fields of work and to play their role as an original partner in building society. Women working in Sudan represent 67% of the employees in the government sector, while those working in the field of education and health are higher than men.
- Working Women Association affirms its respect for the laws governing displacement and asylum, in particular those relating to refugee women in general and refugees from South Sudan in particular, but wishes to denounce in the strongest terms the disgraceful work carried out by a terrorist group in the southern refugee camps in the White Nile state in Sudan.
- The targeting of Sudanese teachers who provide educational services to refugee children by a terrorist gang is more than an aggression against teachers is aimed at sabotaging the refugee camps and denying refugees the enjoyment of the rights of refugees provided for in the international conventions governing asylum. As we condemn this terrible crime, we call for the imposition of a deterrent punishment on the perpetrators. We also affirm our demand that this incident, despite its ruthlessness, does not affect Sudan's positive attitude towards hosting refugees and providing humanitarian services to them despite the scarcity of Sudan's resources.
- Working Women Association affirms that it will continue to support Sudanese working women and in particular the teacher in carrying out her mission in the field of education and appeals to the working women teachers to continue their mission in educating generations and young citizens, displaced persons and refugees despite the risks they face in refugee and IDPs camps.
- Working Women Association calls upon the International Council for Human Rights to take note of the terrible events in the refugee camps in the State of White Nile. It hopes that all relevant parties and humanitarian aid partners will take responsibility for extending humanitarian security and protecting humanitarian workers. Punishment for the perpetrators of the crime they committed a terrible crime against women working in the field of education by applying the rule of law to any infringer on the rights of Sudanese women.
