Excellency,




We take this opportunity to renew to your Excellency the assurances of our highest consideration.

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS  
BETWEEN  
THE REPUBLIC OF LATVIA AND THE REPUBLIC OF EQUATORIAL  
GUINEA**

The Republic of Latvia and the Republic of Equatorial Guinea,

With the purpose to promote mutual understanding and strengthen the friendship and co-operation among their two peoples;


On the basis of the principles and purposes of the Charter of the United Nations and international law, particularly on the respect for and promotion of international peace and security, equality among States, national sovereignty, independence, international treaties, territorial integrity and non-interference in the internal affairs of States,

Have decided to establish diplomatic relations at ambassadorial level, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961, as of the date of the signing of this Joint Communiqué.

In witness thereof, the undersigned representatives, duly authorised by their respective Governments, have signed this Joint Communiqué in triple in English, Spanish and Latvian languages, all texts being equally authentic.



**COMUNICADO CONJUNTO  
SOBRE ESTABLECIMIENTO DE RELACIONES DIPLOMÁTICAS  
ENTRE  
LA REPÚBLICA DE LETONIA Y LA REPÚBLICA DE GUINEA  
ECUATORIAL**

La República de Letonia y La República de Guinea Ecuatorial,

Con el propósito de promover el entendimiento mutuo y de estrechar la amistad y cooperación entre ambos pueblos,

Sobre las bases de los principios y propósitos de la Carta de las Naciones Unidas y del derecho internacional, particularmente en el respeto y la promoción de la paz y la seguridad internacionales, la igualdad entre los Estados, la soberanía nacional, la independencia, los tratados internacionales, la integridad territorial y la no injerencia en los asuntos internos de los Estados;

Han decidido establecer Relaciones Diplomáticas, a nivel de Embajadores, de conformidad con las disposiciones de la Convención de Viena sobre Relaciones Diplomáticas, del 18 de abril de 1961, a partir de la fecha del presente Comunicado Conjunto.

En fe de lo cual, los abajo firmantes, debidamente autorizados por sus Gobiernos, firman el presente Comunicado Conjunto en tres ejemplares originales, en los idiomas inglés, español y letón, siendo todos igualmente auténticos.
