
Excellency,

PROTOCOL
ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN
THE PRINCIPALITY OF ANDORRA AND
THE REPUBLIC OF UGANDA

The Principality of Andorra and the Republic of Uganda guided by mutual willingness to develop relations of friendship and cooperation between the two countries in political, economic and cultural fields have decided to establish diplomatic relations as of the date of signing of This Protocol.

The Two Sides have reached an agreement to develop their relations on the basis of principles of equality of states, mutual respect, independence and sovereignty, non-interference into internal affairs of each other in accordance with the United Nations Charter.


Both Sides are convinced that the establishment of diplomatic relations between the Principality of Andorra and the Republic of Uganda corresponds to the interests of the two states, is not directed against any other country and will facilitate the strengthening of international cooperation and universal peace.

Both Sides have agreed to base their diplomatic relations on the Vienna Convention on Diplomatic Relations, signed on April 18, 1961.

For this, authorized representatives of the Principality of Andorra and the Republic of Uganda have signed This Protocol, in the English and Catalan languages, all texts being equally authentic.
