PROTOCOL

ON THE ESTABLISHMENT OF DIPLOMATIC RELATIONS BETWEEN THE REPUBLIC OF ARMENIA AND THE REPUBLIC OF BENIN

The Republic of Armenia and the Republic of Benin,

Desirous to promote mutual understanding and to strengthen the relations of friendship and cooperation between their two peoples,

Determined to develop these relations guided by the principles of the Charter of the United Nations and international law,

Have decided to establish diplomatic relations at Ambassadorial level, as of the date of signing of this Protocol, in accordance with the provisions of the Vienna Convention on Diplomatic Relations of 18 April 1961.
